#### **Considerations Used in Formulating Options**

- Cost of Odd Year Elections
  - Approximately \$50,000 per election held in odd year
- The Current Election Cycle consists of 3 Staggered Groups of 2 for three years running every year. We need to move into 2 Staggered Groups of 3 for four years running every other year.
  - Seats 1&2 = 2023-2026 to Seats 1 & 2 & ?
    Seats 3&4 = 2024-2027
    Seats 5&6 = 2025-2028 Seats ? & ? & 6
- The longer the timeline to phase in; the higher costs but fewer term adjustments to get where we need to be.
- With a shorter or immediate timeline to phase in; we experience higher savings due to odd year election reduction or elimination; but there are more term adjustments to get where we need to be.

#### **Rules of Implementation if Referendum Passes**

- All seats sworn into office following the 2024 elections would be grandfathered to the 3 times term limit rule.
- Newly elected after 2024 elections would be subject to the 2 times term limit rule.
- Extended terms for the purpose of transitioning to even year election cycle are counted with the current term of the seat holder being extended when considering the limit count.
- Being elected to an abbreviated term for the purpose of transitioning to an even year election cycle is not counted towards the term limit count.
