City Attorney Fernandez stated the ordinance could be changed at a later date, and confirmed there is no one operating under noise sensitive zones.

Planning and Zoning Director Clark and Planning Manager Nelson provided a presentation to include attainable housing density bonus information, changes to the code, definitions, and answered Council questions regarding definitions, responding the accessory dwelling units (ADUs) intent is to increase housing opportunities, and stating ADUs criteria are not tied to attainable housing.

Planning and Zoning Director Clark responded to a Council question regarding resort dwellings, explaining that it is the rental of a single family home for less than 30 days, more than 3x in a calendar year, and noted that if ADUs became a resort dwelling issue the code is enforceable.

Discussion took place regarding half-units, ADUs being exempt from density, lot percentages, parking limitations, and architectural elements.

Mr. Martin Black, agent, requested approval of the pre-annextion of the property which will be used for a self-storage facility, and answered Council questions regarding exact location of the property.

#### D. PRESENTATION WITH ACTION

<u>23-6125</u> Finance Director Linda Senne: Budget 3% Cap

Finance Director Senne presented the request to exceed the 3% budget cap for the FY 2024, and answered Council questions regarding the cap, estimates, implications for the future, carry over from personnel, health insurance, FICA, and Florida Retirement System (FRS).

City Manager Lavallee commented it would be unlikely the City's budget would be able to remain under 3% of the prior year's original adopted budget in the future.

City Engineer Weeden answered Council question regarding multimodal transportation, funding based on last workshop was directed to move forward with overall long term management plan, consultant services, interaction between city and county transportation, Florida Department of Transportation (FDOT), and time frame of project.

Finance Director Senne responded to a Council question regarding property values from the Sarasota County Property Appraiser; as of June 1st values had increased 14%.

Finance Director Senne explained pension fund catch up for police and fire, with the goal to be 100% funded.

A motion was made by Mr. Longo, seconded by Vice Mayor Boldt, to approve the request to exceed the 3% budget cap for FY 2024 Budget. The motion carried by the following electronic vote:

#### E. PRESENTATION

23-6126 City Engineer Kathleen Weeden: Update on the Northeast Park, Including Progress to Date and Timeline to Completion (10 min.) (Dr. Fiedler)

City Engineer Weeden provided a presentation on the Northeast Park project to include park location map and location, public outreach results, facilities to support amenities, timeline of completed activities, delays due to Hurricane Ian, original completion date deadlines, and noted some deadlines may be delayed. She responded to Council question regarding the public workshop date, aiming for August, park impact budget, park impact fees may be lower, funding, and linear park will run along the right-of-way line.

City Engineer Weeden stated the Vicenza neighborhood MURT that runs east from Jacaranda has established good communication with Florida Power and Light (FPL).

Mayor Pachota stated he has heard concerns the new fire station is moving faster than the park, noted the fire station is life saving, and the park project is farther along than people think.

#### City Attorney

City Attorney Fernandez advised Attorney Maggie Mooney will be at the public hearing.

City Clerk

City Clerk Michaels gave a schedule update and noted the Public Art meeting has been cancelled due to a lack of quorum.

## City Manager

City Manager Lavallee gave an update from the Council of Governments (COG), noting Sarasota County is supporting a trolley service, the Sarasota Bradenton International Airport (SRQ) is still the fastest growing as of April, and legislative session starts January. The County funding

received from Housing and Urban Development (HUD) for affordable housing, public workshops, hurricane repair, and mitigation. He noted Fire Station 2 and the water plant are located on a floodplain, and the space could be considered for affordable housing. The County has not released information on criteria for funds distribution.

#### VIII. COUNCIL REPORTS

#### Council Member Howard

Council Member Howard reported on attendance at Planning Commission, the Venice Theatre, and discussion regarding height, architecture, and blue signage. He noted traffic has decreased in the City, restaurants have availability, and stated Venice does not have a growth problem, but a migration problem.

#### Council Member Moore

Ms. Moore reported on the Historic and Architectural Review Board (HAPB), noted the board is cohesive, and doing good work. She noted the quasi-judicial procedure citizens' guide is timely.

#### **Council Member Fiedler**

Dr. Fiedler thanked Clerk Michaels for information to advisory boards. She introduced Steve Carr, Metropolitan Planning Organization (MPO) Citizen Advisory Liaison, and noted six possible City of Venice funding options.

#### **Council Member Longo**

Mr. Longo attended an Economic Development Corporation (EDC) meeting and an excellent team-building exercise.

#### Council Member Frank

Mrs. Frank noted the Public Art Advisory Board meeting cancellation due to lack of quorum, the possibility of combining advisory boards, and issues due to postponement of meetings.

#### Vice Mayor Boldt

Vice Mayor Boldt reported on the Tourist Development Council (TDC), presentation by the Braves, and tourism brought to the area by the park.

#### Mayor Pachota

Mayor Pachota reported on the COG meeting and discussion that occurred regarding meeting procedures. He will meet with City Manager regarding updates in Council Chambers.
