# CALL TO ORDER - MEETING CONTINUED FROM NOVEMBER 27, 2018

Mayor Holic reconvened the meeting at 9:02 a.m.

# **ROLL CALL**

Ms. Gates joined the meeting at 9:05 a.m.

# I. PUBLIC HEARING - ORDINANCE - FIRST READING

# ORD. NO. 2018-41

An Ordinance Amending the Official Zoning Atlas of the City of Venice, Florida, Pursuant to Zoning Map Amendment Petition No. 17-16RZ, Relating to Property in the City of Venice Located at the Southeast Corner of N. Auburn Road and Border Road Owned by SSD Land Holdings, LLC, Rezoning the Property from Sarasota County Open Use Estate (OUE) to City of Venice Planned Unit Development (PUD); Providing for Repeal of all Ordinances in Conflict Herewith; Providing for Severability; and Providing for an Effective Date (Quasi Judicial)

Mr. Shrum, being duly sworn, responded to council questions regarding different information provided to council that was not presented at the planning commission hearing, density on units per acre, and compatibility.

Ms. Fernandez noted council should make their decision based on the current application, and responded to council's inquiry on reducing density based on compatibility.

Discussion followed regarding storm rating on PVC fence, code requirement, left turn lane on Auburn Road, traffic study and improvements, state law requiring developer to do offsite improvements, and developer's

proportion of fair share.

Ms. Fernandez clarified state law on developer's proportion of fair share.

Discussion continued on developer's proportion of fair share, inconsistencies with the landscape plan and changes being made prior to final reading, retention pond depth and permitting, binding master plan, transportation deficiencies, and enforcing prohibitions.

Jeffery Boone, representing Fox Lea Farm, being duly sworn, responded to council questions regarding viewing Fox Lea Farm's presentation at the planning commission hearing, Fox Lea Farm's request for an 8 foot concrete wall, and density level acceptable to Fox Lea Farm.

In response to council questions, Ms. Fernandez spoke to property taking, Bert Harris Act, Joint Planning Agreement (JPA) maximum, vested rights on Planned Unit Development (PUD) request, and compatibility.

Discussion took place on application materials being corrected prior to council making a decision.

Mr. Boone objected to not being allowed to cross examine Mr. Shrum.

Mr. Boone's rebuttal included Fox Lea Farm is not opposed to the Murphy Oaks property being developed but is opposed to current development plan, eight foot concrete wall would mitigate against noise impacts, buffer, replacing and maintaining existing vegetation in the county right-of-way, a proposed stipulation that would require applicant to submit revised landscape plans for staff's review and approval that provide 100% opacity for landscaping in their buffer area, errors and inconsistencies in the plans, applicant's decision to submit a PUD application and binding master plan, and requested council deny the application unless stipulations are granted and plans are corrected.

Dick Longo, representing Sawgrass Homeowners Association and the Central Venice Coalition, being duly sworn, commented on density, impact of development on Fox Lea Farm and surrounding neighborhoods, Bert Harris Act, stipulations, and requested council to deny the application.

Recess was taken at 10:24 a.m. until 10:35 a.m.

Jeff Wright, Henderson, Franklin Law Firm, on behalf of applicant, being duly sworn, requested to continue this matter and submit corrected documents.

Ms. Fernandez spoke to the hearing process if council approves a continuance.

Mr. Boone requested to be heard prior to council deciding on a continuance.

Herb Lawson, applicant, being duly sworn, provided rebuttal to include property annexation and development expectations, and plan errors.

Clint Cuffle, WRA Engineering, being duly sworn, spoke to reasons for not providing changes after the planning commission hearing and noted changes.

Mr. Boone objected to changes being presented during rebuttal.

Mayor Holic stated objection is noted.

Mr. Lawson continued his rebuttal to include PUD approval by the planning commission, compatibility, addressing neighborhood concerns, the economic benefits of development to the community, and requested council approve PUD application.

Mr. Wright's rebuttal included proposed mitigation measures on compatibility, lack of evidence in the record to support drainage will be affected, commitment to maintain vegetation in the county right-of way, eight foot concrete wall request by Fox Lea Farm, lack of evidence in the record to support noise violations, process of providing notice of proximity to potential home buyers, dimensions on plans, lack of evidence in the record to support a decrease in property values, height restriction, application changes, vested rights, and requested council approve rezoning request along with the conditional use petition, or in the alternative continue the hearing until the corrected documents have been submitted.

Mr. Boone spoke to applicant's request for a continuance, suggested council allow for changes to be reviewed by staff, commented on prioritizing staff's review of the updated application, and disagreed with council picking a continuance date today.

Mr. Longo opposed continuance request.

Mr Lawson had no objection to Mr. Boone's request for staff not to prioritize review of the updated application.

Mr. Wright noted continuance will allow for deficiencies and concerns to be addressed.

Ms. Fernandez recommended continuance to the next meeting if council approves request.

Mr. Boone and Mr. Longo objected to continuance to the next meeting.

Mayor Holic stated objection is noted for both parties.

A motion was made by Council Member Fiedler, seconded by Vice Mayor Daniels, to deny the applicant's request for a continuance. The motion carried by the following vote:

Mayor Holic closed the public hearing.

Discussion took place regarding compact residential community, housing demand, enforcement of prohibitions and burden on city staff, public safety, compatibility with Fox Lea Farm, applicant's request for waivers on streets and sidewalks, comprehensive plan, horse farm operations next to residential communities, errors in the application, Fox Lea Farm's request for an eight foot concrete wall on the southern border of the property, financing for turn lane and street traffic, proposed stormwater plan and retention pond, presentation at the planning commission meeting, proposed development affecting the Sawgrass community, future Murphy Oaks homeowners and City of Venice's quality of life, concern with potential strain on city resources, and Fox Lea Farm's presentation at yesterday's council meeting.

The motion carried by the following vote:

# C. COUNCIL ACTION/DISCUSSION

18-3632 Approve Letter to the Governor of Florida Requesting Replacement of South Florida Water Management District Board (SFWMD) (Holic)

Mayor Holic explained rationale for the request to send a letter to Governor Rick Scott.

A motion was made by Council Member Fiedler, seconded by Vice Mayor Daniels, to approve Item No. 18-3632. The motion carried by voice vote unanimously.

18-3633 Improving our State's Water Quality (Holic)

Discussion took place regarding other communities working on water quality and sharing best practices, and hosting a best practices workshop in 2019.

18-3634 Venice Sunrise Rotary Hometown Hero's Banquet (Holic)

There was consensus to support the Venice Sunrise Rotary Hometown Hero's Banquet.

18-3643 Discussion and Action on Future Uses for the Hamilton Building (Lavallee)

Mr. Lavallee spoke to suggestions on future uses for the Hamilton Building, the building's appraised value, and market rate range for lease revenue.

Discussion took place on placing the building for sale or lease at market rate, startup cost and maintenance of a museum, providing staff's analysis to the Historic Preservation Board (HPB), and history of the cultural campus.

Ms. Fiedler noted reasons presented by Jean Trammell, Chair of the HPB, at the August 28, 2018 meeting for not turning the Hamilton Building into a museum.

Discussion continued on monetizing the building through sale or lease and using proceeds for other infrastructure needs, locations to add an exhibit honoring KMI (Kentucky Military Institute), mobility and master parks study, Lord Higel House, scheduling a historical workshop, leasing the building, similarity between Mr. Lavalle's memorandum and communications received, and access to the Venetian Waterway Park.

A motion was made by Council Member Cautero, seconded by Council Member Fiedler, to direct the city manager to place the Hamilton Building on the market for sale or lease.

Discussion ensued on scheduling a historical workshop in 2019, Lord Higel House, leasing the Hamilton Building, and access to the Venice Area Beautification, Inc. (VABI) building.

An amendment to the motion was made by Vice Mayor Daniels, seconded by Council Member Moore, to place the building on the market for lease only.

Discussion ensued on leasing the building, investigating legal issues for sale, and allowing Mr. Lavallee the option to place the building for sale or lease.

The amendment failed by voice vote 2-4 with Mr. Daniels and Mayor Holic in favor.

Mr. Lavallee commented on emergency access to the VABI building.

The motion carried by voice vote 4-2 with Mr. Daniels and Mayor Holic opposed.

<u>18-3641</u> Mayor and City Council Liaison Appointments

A motion was made by Council Member Fiedler, seconded by Vice Mayor Daniels, to approve Item No. 18-3641. The motion carried by voice vote unanimously.

18-3635 Election of Vice Mayor

Mayor Holic asked if any council members did not wish to serve as vice mayor. Ms. Moore did not wish to serve.

Mayor Holic opened the floor for nominations.

Vice Mayor Daniels moved to nominate himself as Vice Mayor.

Council Member Fiedler moved to nominate Council Member Cautero as Vice Mayor.

Mayor Holic closed the floor for nominations.

By a show of hands, Council Member Cautero was selected as Vice Mayor.
