## Instructions for City of Venice City Council Meeting March 23, 2021

The March 23, 2021 City Council meeting will be held in council chambers at city hall. The meeting will also be simultaneously broadcast live on the City's website and through Zoom. Some members of the City Council may participate in the meeting via Zoom and not be physically present.

To participate in the City Council meeting on March 23, 2021, which begins at 9 a.m., you have the following options:

### 1. Listen to the meeting via phone:

You may listen to the audio only from your phone by dialing 1-929-205-6099 and when the meeting ID is requested, enter 844 5227 7404 and then press the # key.

## 2. Watch the meeting online, but not participate:

You may access the meeting by visiting https://venice.legistar.com/Calendar.aspx. Click on "In Progress" to the far right of the City Council meeting on this date.

# 3. Watch the meeting online and provide public comment prior to the meeting:

You may provide written comments by emailing <a href="mailto:lstelzer@venicegov.com">lstelzer@venicegov.com</a> or by regular mail to City Clerk Lori Stelzer, 401 W. Venice Avenue, Venice, FL 34285. Provide your full name and home address and if you are a city business owner, list the business name and address. All comments received by March 23, 2021 at 8:00 a.m. will be distributed to the mayor, city council members, and the appropriate staff prior to the start of the meeting.

#### 4. Watch the meeting online and provide public comment during the meeting:

To request to speak during the virtual meeting, you must complete the Request to Speak form prior to the start of audience participation or the agenda topic to be placed on a list.

You must fill out all required information or the form cannot be submitted.

## 5. Attend the meeting in-person at 401 W. Venice Avenue, Venice, FL 34285.

While in-person attendance is allowed, due to COVID-19 the City strongly encourages the public to participate through one of the above options instead.

For the March 23, 2021 meeting, please use the meeting link <a href="https://us02web.zoom.us/j/84452277404">https://us02web.zoom.us/j/84452277404</a> to virtually attend using a computer, tablet, or smartphone. Individuals who have pre-registered to speak will be called upon and the appropriate time limits will be enforced - comments must be limited to 5 minutes for city residents and property or business owners, and 2 minutes for non-residents.

If joining from a tablet or smartphone, you will need to download the free Zoom app from your device's app store. If joining from a computer, your computer will automatically download and install (if needed) the Zoom program. If you currently have Zoom installed on your computer, tablet, or smartphone, you may join the meeting by entering the meeting ID 844 5227 7404.
