#### 20-4546

Leigh Holt, Strategic Planning Manager, The Sarasota/Manatee Metropolitan Planning Organization (MPO): 2045 Long Range Transportation Plan (15 min.)

Leigh Holt, Sarasota/Manatee Metropolitan Planning Organization (MPO), provided a presentation and spoke to 2045 long range transportation plan, MPO's role and responsibility, funding, transit needs, investment priorities, and transportation investment survey.

Discussion followed regarding population projections, Pinebrook Road improvements from Center Road to Laurel Road, Center Road to East Venice Avenue level of service (LOS), Venice Avenue bridge, 2019 Northeast area transportation study by Kimley-Horn and Associates, dedicated turn lanes on U.S. 41, evacuation routes, River Road, average project timeframes, percentage of projects funded by municipal bonds, funding sources, revenue projections, and gas tax revenue.

#### **20-4547**

Stantec Senior Consultant, Peter Napoli: Impact Fee Study (10 min)

Peter Napoli, Stantec Consulting, provided a presentation and spoke to project and impact fee background, general government, Emergency Medical Services (EMS) and solid waste impact fees, conclusion/recommendation, and next steps for implementation.

Discussion followed regarding adoption of general government impact fees.

Ms. Fernandez noted code will need to be amended to include impact fees.

Ms. Senne commented on impact fee ordinance, adoption process, and general government impact fee fund.

Mr. Clinch spoke on the solid waste and recycling rate stakeholders work group's approval of solid waste impact fees to include removal of can fees, solid waste and recycling fund, and cost of new trucks.

Discussion followed regarding the stakeholders work group making a presentation to council, recycling surcharge, staff presenting a draft ordinance at the next council meeting, general and solid waste impact fees, consolidating impact fees, the city's control over impact fees, and adoption timeframe.
