Proposed Ordinance Title: ORD. NO. 2025-18: AN ORDINANCE AMENDING CITY OF VENICE ORDINANCE NO. 2024-25, WHICH ADOPTED THE OFFICIAL BUDGET OF THE CITY OF VENICE, FLORIDA FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2024 AND ENDING SEPTEMBER 30, 2025; BY INCREASING THE TOTAL REVENUE BY \$1,494,951 AND TOTAL EXPENDITURES BY \$1,494,951; AND PROVIDING AN EFFECTIVE DATE
