PLAR24-000 64 640 W. Venice Ave - Seeking Recommendation to City Council for Ad Valorem Tax Exemption to Improvements of Historical Resources in the Local Register

Historical Resources Manager Klinkhamer presented the completed review documentation, the process for exemption, the recommendation to City Council under review today, the applicable Land Development Regulations (LDR) section, review of renovations done, and answered the Board questions on whether property had storm damage, how cost for project is determined, and whether building department inspections were considered.

A motion was made by Vice Chair Trammell, seconded by Ms. Dearybury, that based on review of the application materials, the staff report and testimony provided during the public hearing, the Historic and Architectural Preservation Board finds this petition is consistent with the Comprehensive Plan, and IS in compliance with the Chapter 66, Article VII of the City of Venice Code of Ordinances, and with the affirmative Findings of Fact in the record, recommends to City Council approval of Ad Valorem Tax Exemption to Improvements of Improvements of Historical Resources in the Local Register for PLAR24-00064 - 640 W.
