SUBJECT / TOPIC: Report of Advisory Board Action on Legislative Referral (Mayor Feinsod) – 5/24/2022 re: methods to reduce or eliminate single use plastic water bottles in all municipal buildings.

BACKGROUND INFORMATION: The council directed the EAB through a legislative referral to research methods to reduce or eliminate single use plastic water bottles in all municipal buildings as follows:

Motion by Vice Mayor Pachota, seconded by Dr. Fiedler to direct the Environmental Advisory Board (EAB) to research methods to reduce or eliminate single use plastic water bottles in all municipal buildings. Motion carried 7-0.

The board recently discussed the matter (*see attached minutes*) and determined the best way to accomplish the reduction would be for the city to adopt a policy to install water bottle refilling stations in all new municipal buildings and park restroom facilities. It is also advisable to retrofit in existing buildings where practical.
