DECLARATION OF MAINTENANCE RESPONSIBILITIES

WHEREAS, PAMLICO POINT MANAGEMENT, LLC, a Florida limited liability company, hereinafter referred to as "Owner," is the owner of the real property within the city limits of Venice, Florida, known and identified as "VICENZA PHASE 2," on the following described real property, hereinafter referred to as the "Property":

TRACT 700, OF VICENZA PHASE 1, AS PER PLAT THEREOF RECORDED IN OFFICIAL RECORDS PLAT BOOK 53, PAGE 239, OF THE PUBLIC RECORDS OF SARASOTA COUNTY, FLORIDA

WHEREAS, NEAL COMMUNITIES OF SOUTHWEST FLORIDA, LLC, a Florida limited liability company, hereinafter referred to as "Developer," is developing the Property and desires to have its plat/site plan approved and to have the City of Venice undertake certain responsibilities with respect to said development.

WHEREAS, the Developer and City have agreed that certain roads and drainage facilities shall remain privately owned, operated and maintained, at no expense to the City of Venice, after completion of construction.

WHEREAS, the VICENZA NEIGHBORHOOD ASSOCIATION, INC., a Florida not for profit corporation, hereinafter referred to as "Association," is the legal entity designated by Developer to serve as the perpetual maintenance entity to privately own, operate and maintain the private roads and drainage facilities pursuant to the Declaration of Covenants, Conditions and Restrictions for Vicenza.

NOW THEREFORE, the Association agrees that upon completion of the construction of the private roads and drainage facilities by Developer, the Association shall maintain and repair to applicable City specifications those private roads and drainage facilities located on the Property, the legal description of which is set forth above, and as further evidenced by Exhibit "A," attached hereto and incorporated herein.

This Agreement shall run with the land described above and shall insure to the benefit of and shall be binding upon the parties hereto, their successors and assigns.
