RESOLUTION NO. 2026-10

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA, REDEDICATING CENTENNIAL PARK IN HONOR OF THE CITY OF VENICE CENTENNIAL; AND PROVIDING AN EFFECTIVE DATE

Whereas, the City of Venice proudly marks one hundred years of municipal leadership, civic service, and community building that have shaped the character, values, and quality of life enjoyed by its residents; and

Whereas, Centennial Park stands as a lasting symbol of the City's rich history and civic pride, serving as a meaningful gathering place to reflect upon the past while looking toward the future; and

Whereas, the City of Venice Centennial celebration provides an opportunity to honor the dedication and service of Mayors and City Council members, past and present, whose leadership and vision have guided the City through a century of progress and growth; and

Whereas, this special rededication and legacy ceremony commemorates the City of Venice Centennial in conjunction with the park's historical connection to the Post Office Centennial, as well as a performance of the official Centennial song, "Venice, Forever Home"; and

Whereas, the celebration serves as a tribute to one hundred years of civic pride and a commitment to the generations yet to come; and

Whereas, the park rededication stands in honor of those who have provided leadership and service, contributed to its past and present success, and celebrates a meaningful milestone in the City's shared history.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA, as follows:

SECTION 1. The whereas clauses above are ratified and confirmed as true and correct.

SECTION 2. Centennial Park, being a dedicated City park, located at 200 W. Venice Avenue shall hereby be named in honor of the City of Venice Centennial.

SECTION 3. This Resolution shall take effect immediately upon approval and adoption as provided by law.
