Consultant Chris Schoonover, Capital City Consulting: 2020 Legislative Session Discussion

Chris Schoonover, Capital Consulting, responded to council questions on the best method to communicate the city's position to state legislators and the top three issues affecting south Florida communities.

Ms. Stelzer noted written communication was included in the agenda packet.

Roger Clark, being duly sworn, provided a presentation and spoke on zoning map amendment, site characteristics and photographs, surrounding property comparison table, future land use, zoning map, zoning comparison table, comprehensive plan consistency, mitigation techniques, criteria for rezone amendments, and planning commission's action.

Discussion followed regarding compliance with the comprehensive plan and joint planning agreement (JPA) area four.

Annie Boone, Boone Law Firm, being duly sworn, spoke to request, property location, annexation, zoning, and land use designation.

No one signed up to speak.

Mayor Holic closed the public hearing.

Ms. Stelzer read the ordinance by title only.

Mayor Holic opened the public hearing.

Ms. Fernandez queried council members on conflicts of interest and ex-parte communications since the last hearing. Mr. Newsom noted watching the the video from the last meeting and Mr. Daniels disclosed driving by the property.

Ms. Stelzer noted written communication relating to the Gulf Coast Community Foundation (GCCF) was received and will be included as part of the record.

Mr. Daniels disclosed receiving complaints of an email template that was created and sent to residents.

Mr. Clark, being duly sworn, spoke to the stipulations in the ordinance and responded to council questions regarding non-residential uses, height, and adding stipulations.

Discussion followed regarding combining height variance with second reading of the ordinance.

Ms. Fernandez explained the variance is solely about height and is a separate petition that should be addressed on its own.

Discussion ensued regarding motion language, modified binding master plan (BMP), and height variance.

Jeffery Boone, Boone Law Firm, being duly sworn, commented on combining height variance with second reading of the ordinance and Ms. Gates asking questions on building height.

Ms. Fernandez noted comments made during the rezone hearing have to be made as part of the hearing for the variance if both items are combined.

Recess was taken at 10:57 a.m. until 11:02 a.m.

Mr. Boone spoke to revised proposed stipulations regarding cell tower, adding "proposed lakes" to the table in the BMP, consistency with the comprehensive plan, and proposed number of units.

Pat Neal, Neal Communities, being duly sworn, spoke on sound barrier between proposed development and I-75, and requested council not add a stipulation for a wall.

Michael Keane, Keane Acoustics, being duly sworn, spoke on conducted noise study on the property to include metrics used, monitoring locations, noise impact area, and mitigation techniques.

Mr. Neal spoke to sound improvements and noise mitigation techniques.

Mr. Boone spoke regarding modification of existing zoning, The Bridges property to include affordable housing concept and density, and inclusionary zoning.

Mr. Neal provided a presentation and spoke to affordable housing, cost of building homes, and homes that meet standards for the working family in Sarasota and Manatee counties.

Discussion followed regarding the planned unit development (PUD), developing a section of the property like a John Nolen community, height variance, The Bridges BMP, the city's process to amend an existing development without rezoning the property, comprehensive plan, commercial mixed-use (CMU), zoning change being in the best interest of the residents, density reduction, I-75 noise concerns, overlay districts, multi-family workforce housing structures, how the property fits into the county's 2020 plan and their expectation of workforce housing, conventionally framed condos, burden on evacuation centers, using block as a base on the first floor, building clubhouses to hurricane code standards for sheltering, GCCF's intention for affordable housing, and binding stipulations carrying forward to the property owner.

Discussion ensued regarding housing market demand, GCCF's aspirations, affordability outside of city limits, whether there is a binding obligation for market rate housing on this property, state and federal funding, impact fees, transportation concurrency, price range of affordable homes in the community, Habitat for Humanity houses, Treviso Grand apartments, maintenance on apartments versus single-family detached homes, PUDs, losing commercial property, requesting new gated communities to have a shelter, requesting developers to build amenity centers to hurricane standards, and liability insurance.

Recess was taken at 12:28 p.m. until 1:30 p.m.

A motion was made by Council Member Daniels, seconded by Council Member Gates, to table Ordinance No. 2019-19. The motion carried unanimously by voice vote.

Mr. Shrum, being duly sworn, commented on the current zoning designations for both properties, consistency with the comprehensive plan, application and process to amend zoning, The Bridges BMP to include workforce housing, pre-annexation agreement, applicant's proposal, comprehensive plan strategy on hurricane shelters, determining shelter space based on types of developments, land development regulations (LDRs), the county's control of hurricane shelters, and responded to council questions on CMU development requirements.

Mr. Shrum noted CMU is used to accommodate more non-residential developments than a PUD zoning district, and responded to council questions regarding the five percent non-residential cap.

Discussion followed on the approved height variance in the BMP.

Mr. Shrum requested to add parcel ID number to the cell tower stipulation and noted staff has not reviewed the new information on acoustics.

Discussion continued regarding pre-annexation agreement requirement to widen Laurel Road from Knights Trail to the end of the development, hurricane shelters within PUDs, height variance, workforce housing, and the county's control of hurricane shelters.

Jerry Jasper, 130 Burano Court, being duly sworn, spoke to the move of The Bridges property from the Laurel Road corridor to northeast Venice for compatibility.

Mr. Boone spoke on districts proposed by GCCF for The Bridges BMP to include town center, neighborhood and neighborhood center.

Mr. Neal commented on GCCF's plan, ability to build and sell homes in the \$220,000 range, and Florida House Bill (HB) 7103 prohibiting inclusionary zoning.

Mayor Holic closed the public hearing.

A motion was made by Council Member Daniels, seconded by Vice Mayor Cautero, that Ordinance No. 2019-19 be approved and adopted with the revised proposed stipulations regarding the cell tower to include number four "Parcel ID No. 0389-00-2031 containing the cell tower facility shall not be included in the five percent non-residential limit for the GCCF planned unit development (PUD)" and removing the second sentence, and applicant to provide the revised binding master plan to reflect all changes. Discuss City Policy Changes in Reference to Sewage Spill on Jacaranda Boulevard (Holic)

Mayor Holic spoke to meeting with Mr. Neal regarding the sewer spill, accident, having staff include language in the developer's agreement for the city to receive compensation and recoup costs, requiring water and sewer lines to be clearly marked on site and development plans, each

parcel having clear instructions on who to contact in case of a line break, having an established plan on what the city or county must do in an event of a line break, costs associated with the plan should be afforded by the property owner, the county should notify the city when on city property, the city's utility department should be notified and have a representative on site if a sewer line breaks on city property and cost of city representative should be added to repair costs, permit for excavations, having an inspector check depth of lines, and communication between the city and county.

Discussion followed on locate service.

Discussion ensued regarding the county verifying pipe depth, communication between the city and county, ten year recap of spills, staff's proposal for excavation permits, and the city's rule on spills.

Mr. Vargas commented on reporting spills to the Health Department and Florida Department of Environmental Protection (FDEP).

Discussion followed regarding regulatory process to include sanctions.

Mr. Jackson referenced code language on protection of underground utility lines during excavation.

Discussion continued regarding scheduling a post-mortem meeting, punitive damages, directing staff to research regulatory process, and obtaining the county's report.

Mayor Holic passed the gavel to Vice Mayor Cautero.

A motion was made by Mayor Holic, seconded by Council Member Gates, to direct staff to develop an appropriate method of recouping the expenses incurred from a break in any utility lines within the City of Venice. The motion carried unanimously by voice vote.

Vice Mayor Cautero returned the gavel to Mayor Holic.
