Regarding: Noise Abatement Abutting I-75

Please do not allow Murphy Oaks or any other development abutting Interstate 75 to proceed without addressing noise abatement.

Venice residents rely on local government to provide for the well-being of its citizens including protection from adverse environmental influences. Excessive noise creates adverse physical, physiological and psychological health effects. Elevated environmental sound levels such as highway noise can cause hearing impairment, hypertension, ischemic heart disease, annoyance and sleep disturbance. Changes in the immune system and birth defects have been also attributed to noise exposure. The Journal of Environmental Research and Development (Vol. 8 No. 4, April-June 2014) provides an excellent reference regarding health effects of noise.

The Federal Highway Administration (FHWA) encourages local governments to use their authority to regulate land development to either prohibit development of noise sensitive land uses adjacent to highways or establish requirements for developers to plan, design, and construct noise sensitive development using methods that minimize noise impacts.

Venice government has not taken the necessary steps to protect Murphy Oaks and other future residents from the considerable highway noise that 6 lane I-75 generates. This is an oversight without consequence until now. The proposed development is Venice's first RSF 2 neighborhood abutting I-75. What is done here will also set a precedent for any future I-75 abutting development. A twenty plus mile drive from Sarasota on I-75 reveals that all RSF 2 developments have solid walls to mitigate highway noise. The same can be observed south of Venice. What do these local governments and/or developers know that is not being addressed by the City of Venice and/or SSD Land Holdings?

Imagine a home where you can't enjoy conversation at a family barbeque due to noise, where a distressed child's cry is lost in the highway's din, where the roar of a heavy semi or scream of a motorcycle disrupts sleep night after night. This is not the Venice anyone desires.

Venice's Council, Planning Commission, Planning and Zoning Departments and perhaps others need to correct the oversight and put in place regulations that allow for future development while assuring the I-75 abutting neighborhoods will be both enjoyable and a healthy place to live. Failure to do so may expose Venice and its tax payers to health claim and other liabilities as the effects of excessive noise takes its toll. The argument that the highway was there at the time the new home owners purchased is a weak one at best. There is no way to really estimate how noisy the neighborhood will be without expert acoustical engineering evaluation. Experts are called upon to determine drainage, traffic, sewer and water utilization, wildlife presence etc. Now is the time to add highway noise assessment to the requirements. There are engineering firms that can do the assessment and make appropriate recommendations. There is no need to gamble with Venice citizen's well being.

Chapter 23 of the Code of Federal Regulations Part 772 (23CFR 772) entitled "Procedures for Abatement of Highway Traffic Noise and Construction Noise" contains the federal regulations for the assessment of traffic noise impacts and abatement. Chapter 335.17 of the Florida Statutes requires the use of 23 CFR 772 for traffic noise impact assessment. These regulations can be adopted as is or modified to meet our local needs.

Two Requests of the City Council

Assure implementation of noise abatement zoning regulations appropriate for future I-75 highway abutting developments prior to accepting/approving development applications and plans.

Initiate a risk assessment of Venice's liabilities due to health issues and other claims arising in future years from failure to head Federal and State recommendations to establish requirements for developers to plan, design, and construct noise sensitive development.
