**Subject:** Council Agenda Items re Preserves of Venice

Mr. Mayor and Council Members,

I am writing today regarding Agenda Items CC-16-03-PP, 16-01-CU, 16-01-RZ and Ordinance No. 2107-21.

I sincerely apologize that I can't be present at the Council Meeting on Tuesday, Oct 10. Unfortunately, I was infected by some waterborne bacteria clearing neighborhood drains after Irma that has had me hospitalized and now under strict Dr's care.

Regardless, I expect you will remember our opposition to the rezoning and other requests by the developer of The Preserves and that your evaluation of the overall situation resulted in your request of the developer to "work out the objectionable issues" with Fox Lea, Waterford and Sawgrass.

Unfortunately, from my perspective that has not occurred. I personally have had 3 relatively short phone calls from the developer, one meeting scheduled for September that was cancelled ( I was never informed of the reason for the cancellation. ) and one meeting that, although my hospitalization did not allow my participation, our representatives reported no resolution of any of our objectionable issues.

The Preserves development plan as it exists is not compatible with the existing neighborhoods.

The Preserves plan dramatically increases traffic in the area with no regard for any remediation - specifically turn lanes on N. Auburn Rd.

The Preserves further exacerbates the already precarious stormwater management problems associated with Curry Creek and other streams in the area.

The Preserves plan reduces the quality of life in Sawgrass and Waterford by adding to the highway noise from I-75.

The Preserves degrades the country / suburban aspect of N. Auburn and Border Rds by stacking homes as tightly and as closely to the roadways as possible.

The Preserves ignores the current zoning regulations related to lot width, setbacks and coverage percentage.

There are a number of other objections that I am sure you will hear from Fox Lea and/or Waterford as well as other independent citizens.

Approval of the Preserves plan as it exists does nothing to improve the quality of life for anyone in the City of Venice. With all due frustration at not being able to testify in person but with my deepest sincerity and respect for your good judgment I ask that you reject the applicant's requests.

Dear Sir or Madam,

It has come to my attention that another meeting will take place regarding the building of 118 homes where only eight homes were formerly allowed to be built on North Auburn Road and Border Road. We are home owners in Sawgrass and Triano, and we continue to be upset and concerned about the negative impact this decision will have on our property values, our quality of life, and most importantly on the environment.

As I stated in a previous email, we purchased in Venice because of the nature, quietness, and beauty of the area. We researched and visited many Florida areas including Ft. Lauderdale, Ft. Myers, Sarasota, and Naples when deciding where to purchase, and we settled on Venice due to the above factors. This possible building will greatly decrease these three factors which make Venice an attractive and desirable area in which to live.

Building 118 homes in this area will have a detrimental effect on the Sawgrass and Triano developments as well as on Venice as a whole. There will be environmental changes to the natural aesthetics along North Auburn Road as well as to the plants and animals that live in the area. We are greatly concerned about the increase in traffic, the noise level from local traffic and from 75, and the pollution this increase in vehicles to the area will cause. We are also concerned about how this will impact the water flow from Curry Creek. In addition to the environmental concerns, which are our greatest worry, the impact of these changes will negatively effect the value of our properties in Sawgrass and Triano.

The increased building in the Sawgrass area will be a detriment to Venice as a whole, increasing the number of people to our area and overcrowding the highways as well as the beaches. Venice Beach is a quiet retreat for those who don't want the hustle and bustle of busier beaches such as Naples and Siesta Key. This increased building will only decrease the serenity of Venice.

We are very upset that our quality of life will be severely impacted and we urge you to prevent this redevelopment. Venice needs to remain as one of the few coastal towns that retains the beauty, nature, peace, and serenity of Florida.

We attended the all day city council meeting about the Preserves of Venice on June 27, 2017. We were very disappointed on how The Council handled these procedures. We thought it was pretty evident that they should reject this development, of 118 units in a very small area off a very narrow county road with no room for turning lanes. Why would The Council want to disrupt a very prominent business that brings lots of visitors and revenue to our city of Venice? As a resident of Sawgrass, we have real concerns about the types of homes they are going to bring in that don't fit with Sawgrass and Waterford homes in this area. We came away feeling The Council was more concerned about squeezing lots of homes in a small area, next to a six lane interstate and a horse farm that needs to be protected. When we purchased our expensive home off of Auburn in Sawgrass, we had no idea that they would rezone it to accommodate this development. We feel a few of The Council members understood that this is not just an issue between a developer and a horse farm, but involves two prominent and established developments.

Mr. Cautera & Mr. Holic had excellent points that most buyers don't hire attorneys, they have title companies & sign everything, not knowing what they are agreeing to or purchasing. As a past real estate agent, buyers don't realize they are buying next to a horse farm or interstate because they are driven by emotion and then later when reality sets in they will realize where/what they purchased. The Council is going to get an ear full.

Mr. Fraze stated the safety issue with children on horses with noise level of the development which is a real concern. The major concern is a narrow Auburn road with no turning lane and traffic is already very fast there. We feel lots of additional accidents will happen with the number of people living in the new development and all the additional traffic from the other new developments in this area.

If this is approved, we feel this will be a major problem for The Council in the future. Why set the city up for constant complaints?

Thank you for your service and The Council members who did not support this development. In closing, we hope The Council will consider all the negatives that go with this development and realize that it is not a "good fit" for this location. You are elected officials and we hope and pray you will do what is best for ALL residents of Venice!

I spent 26 years in the Navy and when I retired I came back to my roots, only to find devastation everywhere. You only have to look a mile down Border Road to see what Neal Communities has done to our neighborhood. There used to be deer that roamed the area. Not any more, they are not forced to move and seek food and shelter elsewhere. It's a shame. And there has been no improvement on infrastructure other than paving of the two lane roads. That is nice, but it doesn't help the traffic. If anything it's made it worse due to the speeders. Now you want to tear down another area that will make it even more congested. That new neighborhood will be way too dense for the area. There will be at least 200 more cars and no where to go but two lane roads (and that's not counting the cars from the Neal Community). And if you think the two four way stops (Jacaranda and Border/Edmondson and Capri Isle) are dangerous now, just wait. It will be so backed up that people will become irate and when someone gets killed there, it's too late to back up and take away that dense development.
