Section 1. The application of the State of Florida Department of Transportation for a deed is for transportation purposes which are in the public or community interest and for public welfare and the land needed for transportation purposes is not needed for city purposes; that a deed in favor of the State of Florida Department of Transportation conveying all rights, title and interest of the City of Venice, Florida, in and to said lands should be drawn and executed by this city council. Consideration shall be \$1.00.

<u>Section 4.</u> This resolution shall take effect immediately upon adoption by the Venice City Council.
