













Venice, Florida Population 2024

Mayor Pachota and City Council Members -

As residents on Bayshore Circle, my wife Cindy and I appreciate this opportunity to share our safety concerns with you this morning. Thank you.

As residents we regularly walk, bike, and drive Bayshore Drive and Laguna. Many of our walks include our two grandsons, age 3 and 1. Safety is our top priority and we have had far too many close calls while walking and biking.

The Island of Venice has changed, Venice today is not the Venice of ten or twenty years ago - there are more and more people here, both residents and visitors coming onto the Island - which only increases the chances of an accident or serious injury on streets like Bayshore and Laguna. Bayshore/Laguna remains one of three main thoroughfares (along with Venice Avenue and Barcelona) to get to the beach and the jetties.

Please consider -

- Bayshore/Laguna has become a heavily traveled and congested route, currently there is a dangerous mix of cars, golf carts, trucks, service vehicles, construction vehicles, motorcycles, motorized scooters, pedestrians, pet walkers, strollers, wheelchairs, runners, bicyclists and bicycle groups all traveling the same narrow stretch.
- From Harbor the road narrows down from approximately 100' to 20' onto Bayshore, this narrow roadway adds to the congestion, there are no sidewalks, no pedestrian or bicycle lanes - so everyone and every vehicle is on the road at the same time.
- There are no shoulders on either side of the road, in fact, much of the route has open swales for water run-off and that drop off is very close to the road.
- To further add to the dangerous situation, there are numerous landscape, service, and construction vehicles parked on both sides of the road every day.
- The posted speed limit is 25 miles per hour, which given the heavy motor vehicle traffic and mix of pedestrians and bicycles is too fast.
- There are stop signs, but too many motorists either ignore them completely or simply roll through them.
- The current "share the road" effort is not working because motor vehicles do not yield to either pedestrians or bicycles.

I would also point out that many residents expressed their concerns about the safety of Bayshore and Laguna at the March 28, 2023, Venice City Council meeting. Also, Police officers, including Captain Andy Liesensring visited the area and determined that a safety issue existed and recommended to the City's engineering department that a sidewalk would help alleviate the problem. Furthermore, it was reported in the Venice Gondolier that there is an amount in the current 2024 budget to design and build the sidewalk and that the City Council unanimously approved that allocation.
