- Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals, and welfare): The City of Venice has a Fire Pension Plan which provides benefits for retired Firefighters. This has been a necessary feature of employment for Firefighters, whose employment is necessary to maintain public health and safety. This Ordinance contains several proposed amendments to the Plan. The first is a technical revision to the definition of 'Salary'. The second gives the pension board broader discretion to seek recovery of inadvertent overpayments, as provided in the SECURE 2.0 Act of 2023. The third implements the most recent revisions to federal law concerning the required beginning date for required mandatory distributions from qualified retirement plans. The fourth is new language concerning the purchase of service credit under the plan for prior service as a firefighter and prior military service. The fifth and final change is in connection with the firefighter share plan.
