DECLARATION OF MAINTENANCE RESPONSIBILITIES

WHEREAS, NEAL COMMUNITIES OF SOUTHWEST FLORIDA, LLC a Florida limited liability company, hereinafter referred to as "Owner" or "Neal" is the owner of the real property within the city limits of Venice, Florida, known and identified as "FIORE," on the following described real property, hereinafter referred to as the "Property":

WHEREAS, the FIORE NEIGHBORHOOD ASSOCIATION, INC., a Florida not for profit corporation, hereinafter referred to as "Association," is the legal entity designated by Neal to serve as the perpetual maintenance entity to privately own, operate and maintain the private roads and drainage facilities pursuant to the Declaration of Covenants, Conditions and Restrictions for Fiore.

NOW THEREFORE, the Association agrees that upon completion of the construction of the private roads and drainage facilities by Neal, the Association shall maintain and repair to applicable City specifications those private roads and drainage facilities located on the Property, as identified in EXHIBIT "A" attached hereto.

This Agreement shall run with the land described above and shall insure to the benefit of and shall be binding upon the parties hereto, their successors and assigns
