#### **ORDINANCE NO. 2023-14**

AN ORDINANCE AMENDING THE OFFICIAL ZONING ATLAS OF THE CITY OF VENICE, FLORIDA, PURSUANT TO ZONING MAP AMENDMENT PETITION NO. 23-13RZ, TO CHANGE THE ZONING DESIGNATION FOR THE SAWGRASS COMMUNITY GENERALLY LOCATED AT THE WEST SIDE OF NORTH AUBURN ROAD BETWEEN EAST VENICE AVENUE AND EDMONDSON/BORDER ROAD (316+ ACRES) FROM SARASOTA COUNTY RESIDENTIAL SINGLE FAMILY 2 (RSF-2) WITH A PLANNED UNIT DEVELOPMENT (PUD) OVERLAY TO CITY OF VENICE PUD; PROVIDING FOR REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, Zoning Map Amendment Petition No. 23-13RZ ("Petition") has been filed by the City of Venice, to change the official City of Venice Zoning Map designation for the Sawgrass Community, generally the west side of North Auburn Road between East Venice Avenue and Edmondson/Border Road (316± acres), from Sarasota County Residential Single Family 2 (RSF-2) with a Planned Unit Development (PUD) Overlay to City of Venice PUD; and

WHEREAS the subject property is located within the corporate limits of the City of Venice; and

**WHEREAS,** the City of Venice Planning Commission has been designated as the local planning agency in accordance with F.S. 163.3174;

**WHEREAS,** the Planning Commission held a noticed public hearing on April 18, 2023 regarding the Petition and, based upon the evidence and testimony received at the public hearing, voted to recommend approval of the Petition; and

**WHEREAS,** the Venice City Council has received and considered the report of the Planning Commission concerning the Petition; and

**WHEREAS,** City Council held a duly noticed public hearing on the Petition in accordance with the requirements of the City's Code of Ordinances, and has considered the evidence and testimony received at said public hearing.


# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA:

- **SECTION 1.** The Whereas clauses above are ratified and confirmed as true and correct.
- **SECTION 2.** The City Council hereby makes the following findings of fact:
- A. The Council has received and considered the report of the Planning Commission recommending approval of the Petition.
- B. The Council held, after due public notice, a public hearing on the Petition and considered the evidence and testimony received at said public hearing.

- C. The proposed rezoning of the property described herein is in accordance with and meets the requirements of the Land Development Code and is consistent with the City of Venice Comprehensive Plan.
- **SECTION 3.** The Official Zoning Map is hereby amended by changing the zoning classification for the property depicted below and further described in Exhibit "B" from Sarasota County Residential Single Family 2 (RSF-2) with a Planned Unit Development (PUD) Overlay to City of Venice PUD, subject to the following stipulation:
- 1. All land designated as open space in the Sawgrass PUD, at the time of the approval, shall be restricted to open space perpetually, or for a period of not less than 99 years, through an executed legal instrument or instruments signed by all owners of land identified as open space. In addition, the Sawgrass Binding Master Plan, attached hereto as Exhibit "A", is hereby adopted and incorporated by reference.

## Property Description:

As depicted on the zoning map shown below consisting of 316± acres, and as further described in Exhibit "B".



Any discrepancy between the legal description and the map shall resolve in favor of the map.

**SECTION 4.** All ordinances or parts of ordinances in conflict herewith shall be and the same are hereby repealed to the extent of the conflict.

**SECTION 5.** If any part, section, subsection, or other portion of this ordinance or any application thereof to any person or circumstance is declared void, unconstitutional, or invalid for any reason, such part, section, subsection, or other portion, or the prescribed application thereof, shall be severable, and the remaining provisions of this ordinance, and all applications thereof not having been declared void, unconstitutional, or invalid, shall remain in full force and effect.

**SECTION 6**. **Effective date.** This ordinance shall take effect immediately upon its approval and adoption as provided by law.
