Consider the Purchase of a 4.7-Acre Parcel of Land Located at 1280 US Highway 41 Bypass South (Parcel ID No. 0428-11-0001) from Douglas Jeep, Inc. for a Purchase Price of \$11,800,000

Vice Mayor opened the public hearing.

There were no written communications.

Assistant City Manager Clinch provided a presentation on the purchase of the need to relocate the solid waste operations, zoning, the property proposed for purchase, and the age of the current facility.

Finance Director Senne provided further information on the history of the facility move, financing, the budget, the current facility, fleet maintenance, solid waste, the budget breakdown, bond resolution, and answered Council questions regarding savings, and annexation.

City Attorney Fernandez answered a Council question regarding the pending contract and financial obligation on that contract, and potential environmental issues.

Assistant Public Works Director Ashlee Castle answered Council questions regarding environmental issues, reports received, and previous issues being cleared by the Florida Department of Environmental Protection (FDEP).

Discussion took place regarding the breakdown for the 1 million, securing property, fuel tank installation, adding of walls and restrooms, cleanup costs, contamination lines, in compliance with monitoring of current site, and remediation of current site.

Vice Mayor closed the public hearing.

An Ordinance Amending the Official Zoning Atlas of the City of Venice, Florida, Pursuant to Zoning Map Amendment Petition No. 25-05RZ, to Change the Zoning Designation for the Properties Located at 225 Park Boulevard South and 528 Menendez Street (0.6 ± Acres), from Residential, Multi-Family 4 (RMF-4) to Residential, Single-Family 4 (RSF-4); Providing for Repeal of All Ordinances in Conflict Herewith; Providing for Severability; and Providing an Effective Date (Quasi-Judicial)

Vice Mayor Boldt opened the public hearing.

Clerk Michaels read the ordinance by title only.

City Attorney Fernandez questioned Council Members concerning ex-parte communications and conflicts of interest. Mr. Engelke, Mr. Smith, and Vice Mayor Boldt disclosed attendance at the Planning Commission meeting, and Mr. Weed disclosed a site visit.

Written communications were provided in advance.

Senior Planner Nicole Tremblay, being duly sworn, provided a presentation including petition information, location and aerial maps, John Nolen plan, project description, existing conditions, future land use, zoning and proposed zoning maps, site photos, surrounding land uses, planning analysis, comparison of existing and proposed zoning, consistency with the comprehensive plan, conclusion and findings of fact, compliance with the land development code, decision criteria, and conclusion with Planning Commission recommendation, and answered Council questions regarding prior zoning, current owners and length of ownership, the historic marker in Nolen Park, zoning restrictions in the current and old code, and the possibility of having the historical society and/or Historical and Architectural Preservation Board (HAPB) being involved.

Attorneys Annie and Jeffery Boone, agents for applicant, being duly sworn, provided a presentation, introduced the applicant, including an overview of the properties, existing conditions, comprehensive plan strategy, aerial from SC property appraiser, ability to make multi-family work due to cost of land and height restriction, future of Venice land values and height restrictions, consistent with comp land, land development code, requested approval and answered Council questions regarding, size of the lot, and density.

Kristen Hoffschmidt, 232 Gulf Drive, being duly sworn, spoke on behalf of Venice Thrives, stating the district was in conflict with the land development code, regarding density and affordability, and increase rather than reduce zoning for affordable housing.

Planning and Zoning Director Clark, being duly sworn, stated this is consistent with the John Nolen plan.

Jeffery Boone, commented on the height allowance, feasibility of multi-family in the location, applicant being consistent with the John Nolen Plan, and providing a legacy to his family.

Vice Mayor Boldt closed the public hearing.
