CALL TO ORDER

Mayor Holic called the meeting to order at 9:00 a.m.

ROLL CALL

Present: 7 - Mayor John Holic, Council Member Kit McKeon, Council Member Jeanette Gates, Council Member Bob Daniels, Council Member Deborah Anderson, Council Member Richard Causero and Council Member Fred Fraize

ALSO PRESENT

City Attorney Dave Persson, City Clerk Lori Stelzer, City Manager Ed Lavalley, Assistant City Manager Len Bramble, Assistant City Clerk Heather Taylor, Recording Secretary Mercedes Barcia and for certain items on the agenda: Fire Chief Shawn Carvey, Police Chief Tom Mattmuller, Development Services Director Jeff Shrum, and City Engineer Kathleen Weeden.

INVOCATION AND PLEDGE OF ALLEGIANCE

Mayor Holic held a moment of silence for lives lost in Orlando. Ms. Stelzer offered an Invocation followed by the Pledge of Allegiance led by Chief Mattmuller.

Harry Moses performed a Flag Day presentation and Mayor Holic presented him with a Flag Day proclamation.

I. RECOGNITION

Mayor Holic recognized Fire Battalion Chief Scott Blanchard, Police Officer Matt Sauchinitz, Detective Rob Goodson, and Police Officer Adam Daneman for awards received.

II. AUDIENCE PARTICIPATION

Don O'Connell, 500 Hauser Lane, commented on public safety and road bond referendums, the potential impact on residents with emphasis on mobile homes and gated communities, roads on the road bond being public roads, and lack of public input regarding the public safety bond, and expressed concern with stacking two bond issues.

Sandy McGowan, Sandy's Designer Clothing, expressed her opposition with charging owners a rental fee for sidewalk use and suggested further review of special event promoters using parking for free.

Erin Silk, Venice MainStreet, expressed support of Ordinance No. 2016-10 and commented on the current limitations on property owners in the district.

Don Hay, Venice Heritage Inc. and Venice Area Beautification Inc., commented on the opportunity to create a museum and archives with the new library, funding for development, potential locations for the new library, and building a multi-use facility on the island.

John Ryan, Venice Area Chamber of Commerce, commented on renting of sidewalks to include safety issues, compliance with ADA standards, current fees paid by businesses, how the fee amount will be determined, and addressing problem locations.

Discussion took place regarding the inability for council to attend the hearing due to there being a city council meeting the same day.

A motion was made by Council Member Gates, seconded by Council Member Daniels, that Item No. 16-2053 be approved.

Discussion continued regarding the intent of the motion, cost savings to citizens, and a presentation on impact fees being provided by the county.

The motion carried by voice vote unanimously.

Authorize the Mayor to Execute Work Assignment No. 401-2016-28 with American Infrastructure Development, Inc. in the Amount of \$180,506 to Provide Professional Services Related to Design and Construction of T-Hangars at Venice Municipal Airport

Discussion took place regarding concern with the t-hangars being constructed without sprinklers.

Chief Carvey stated that the t-hangar project has not been reviewed and expressed the importance of sprinklers and fire safety.

Mohsen Mohammadi, American Infrastructure Development Inc., provided a background on the fire codes and the design and construction of the t-hangars, and purpose and use of t-hangars and responded to council questions regarding storage of flammable liquids.

A motion was made by Council Member Daniels, seconded by Council Member

McKeon, that Item No. 16-2054 be approved.

Discussion continued regarding funding the sprinklers to be proactive and possibly including the requirement in the ordinance for future reference.

The motion carried by voice vote with Mr. Fraize opposed.

Discussion took place regarding transferring all of the streets within the city and future costs for road repairs and maintenance.

A motion was made by Council Member McKeon, seconded by Council Member Gates, that Item No. 16-2055 be approved.

In response to council questions, Mr. Lavalley clarified that the road was mistakenly not included in the road transfer agreement and the county will conduct maintenance prior to transfer to the city.

Discussion continued on potential safety issues with there being no safety rails.

The motion carried by voice vote unanimously.

An Ordinance Amending the Code of Ordinances of the City of Venice, Florida, Chapter 86, Land Development Code, Article V, Use Regulations, Division 4, Business Zoning Districts, Section 86-92, CG Commercial, General District and Section 86-93, CI Commercial, Intensive District; Providing for the Revision of the General Intent Statement for the CI District by Removing Language Referencing Highly Automotive-Oriented Uses and Uses of a Neighborhood or General Commercial Type and to Expand, Clarify and Reorganize Uses in the CG and CI Zoning Districts; Providing for Repeal of all Ordinances in Conflict Herewith to the Extent of Such Conflict; Providing for

Severability and Providing an Effective Date

Ms. Stelzer read the ordinance by title only.

Mayor Holic opened the public hearing.

Ms. Stelzer stated no written communications have been received.

Mr. Shrum provided a brief history to include issues related to uses with three zoning districts and intent of the ordinance.

David Healey, Calvin Giordano and Associates, reviewed existing zoning codes, the tasks to examine the commercial general (CG), commercial industrial (CI) and industrial light manufacturing and warehousing (ILW) zoning categories and to identify any recommended changes, the approach taken to identify alternative solutions and to prioritize recommendations, implementing the step one recommendations, and the principal objectives.

Luis Serna, Calvin Giordano and Associates, commented on district intent, determination of uses, organization and definitions of CG and CI categories and uses, changes in CG and CI to include treatment of restaurant use, elimination distinction between banks and drive-thru facilities, provisions for brew pubs, uses now allowed such as retail, personal services and professional offices, and multi-family dwelling unit special exceptions.

Mr. Shrum commented on the request to carry CG standards to the CI district regarding multi-family dwelling density and responded to council questions regarding changing the ordinance prior to the comprehensive plan update completion, there being no conflict with the request and the current comprehensive plan, ongoing request to change zoning due to constraints on property owners, and future changes in the land development code.

Discussion ensued on potential for the Seaboard area, the intent to simplify and standardize, concern including housing, and whether there is a current issue with residents wanting housing.

Ms. Stelzer stated no one signed up to speak.

Mayor Holic closed the public hearing.

A motion was made by Council Member Gates, seconded by Council Member McKeon, that Ordinance No. 2016-10 be approved on first reading and scheduled for final reading as revised to include CG district wording on maximum density of 18 units per acre.

Discussion followed regarding removing the multi-family section.

Mr. Persson responded to council's concern regarding modifications during first reading of the ordinance and highlighting the changes for second reading.

A motion was made by Council Member Anderson to amend the ordinance to delete any reference regarding housing.

Mayor Holic suggested postponing action on first reading to the June 28, 2016 city council meeting to allow for changes to be made to the ordinance.

Mr. Shrum responded to council questions regarding time sensitivity.

Council Member Anderson withdrew her amendment.

A motion was made by Council Member Daniels, seconded by Council Member Anderson, that Ordinance No. 2016-10 be revised to include CG district wording on maximum density of 18 units per acre and postponed until the June 28, 2016 city council meeting.

Mr. Persson clarified the intent of the motion to postpone for staff to bring back an ordinance that includes the presented verbiage on maximum density.

Discussion continued on priority of motions and potentially postponing until after lunch.

The motion carried by voice vote with Ms. Gates and Mr. McKeon opposed.

Recess was taken from 10:56 a.m. until 11:05 a.m.

Mr. Nash reviewed the executive summary for the police officer pension trust fund to include the current market value, comparative performance trailing and fiscal year returns, and comparative performance total funds and responded to council questions regarding clarity of information on the spreadsheets, alternative investing options, where the four year smoothing is derived from, contributions from the city and police officers, and management of the fire pension plan.

Mr. Lozen provided an update on actuary funding to include percentage of retirees, volatility for funding and reduction in city's funding obligation to the plan.

Mayor John Holic: Options to Fund the Police and Fire Pension Liability (10 min.)

Mayor Holic left the dais to conduct his presentation on funding of the police and fire pensions to include previous recommendations for millage increases, previously proposed letter to the Sarasota County Board of County Commissioners regarding cost for routine patrol services, effect of taxes on county and city residents, idea of a municipal service taxing unit (MSTU), past payroll for fire department, current overage, four proposed options to fund pensions, transparency of fire taxes, and looking into a fire service tax and responded to council questions regarding tax deductions of the fire tax and selling or leasing government owned assets.

Mayor Holic returned to the dais.

Mr. Daniels left the dais to add additional information to include the general operating budget problems, causes, possible solutions and proposal to remove the fire department from the general fund section of the budget and establish a fire fee to support fire department operations.

Discussion continued on best practices in other communities. non-profit payments to municipal service benefit unit (MSBU) and total reserves used this fiscal year.

Mr. Daniels returned to the dais.

Discussion ensued on the need for a consultant, the need for open discussion with the county, possible tax increases, and further discussion at the June 28, 2016 city council meeting.

Mr. Lavallee stated he will have this item on the next agenda for council action.
