SUBJECT / TOPIC: Renaming of the Centennial Park Gazebo

BACKGROUND INFORMATION:

The City Council initiated an application to rename the Centennial Park Gazebo in recognition of Robert and Susan Vedder for their longstanding service and contributions to the City of Venice. Robert Vedder was instrumental in securing the funding necessary for the construction of the original gazebo at Centennial Park. In addition, both Robert and Susan Vedder have demonstrated exceptional dedication to the Venice community through extensive volunteer efforts that have enhanced the quality of life for City residents.

Approval of the resolution would formally rename the Centennial Park Gazebo as the Robert and Susan Vedder Gazebo, effective immediately upon adoption.

The estimated cost associated with this renaming is \$1,250-\$1,500. This cost includes the following: (1) design and fabrication of a permanent replacement sign or plaque, (2) removal of existing signage if applicable, and (3) installation of new signage. Funding for this expense can be accommodated within the existing departmental budget.

The Public Works Department has provided an example of the new proposed plaque.

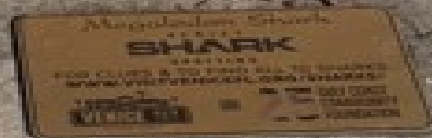
