Introduction of the Transportation and Multi-Modal Master Plan Project (Jonathan Kramer, Assistant City Engineer, Jared Schneider, Project Manager, and Hanna Shaffer, Urban Planner, Kimley-Horn & Associates)

Assistant City Engineer Kramer, Hannah Shaffer, Kimley-Horn Urban Planner, and Jared Schneider, Kimley-Horn Project Manager, spoke on overview of project, purpose of creating plan, population changes, roadway ownership and maintenance responsibility, Capital Improvements Program (CIP) and Capital Improvement Schedule (CIS), project scope, document review and analysis, reviewing multi-modal recommendations received, plan development public engagement, overall schedule, next steps, future engagements activities, and answered Board questions regarding main topic of interest, addressing county ownership of roads, increase in population, whether there is a current transportation plan, whether population counts includes seasonal residents, categorizing of City, County, and State roads, complete streets principle in the Comprehensive Plan, suggestion for a connections between parks, importance of community outreach, past consultant work with Kimley-Horn, involving pedestrian and other modes of transportation, whether it addresses private roads, and length of community engagement process.

Bicycle Advisory Committee and Bicycle Friendly Community Application (Darlene Culpepper, Bicycle Pedestrian Program Coordinator)

Bicycle Pedestrian Program Coordinator Culpepper spoke on her position with the City, the City's Silver Bicycle Friendly rating, the four year application completed this year, application details, report card of City's current status, recommendations for advancement to gold status, recommendation for dedicated bike parking for events, hosting a bicycle safety class, the monthly bike ride at City Hall, Office of Greenways and Trails' Trail Towns Program, and answered a Board question regarding coordination with the Multi-Modal Plan development. Mayor Pachota answered the Board questions regarding current actions that can be done by the Board to assist in advancing the City's status, and acting on the special event requirement recommendation.

Intracoastal Waterway Sites Work Plan Update (James Clinch, Assistant City Manager)

Assistant City Manager Clinch spoke on the County's Neighborhood Parkland Acquisition Program, two potential properties, aerial map, size

of sites, location, Venetian Waterway Trail on properties, being a tax funded program through Sarasota County, qualifications for program, currently owned by West Coast Inland Navigation District (WCIND), properties being deemed as surplus, protecting them for public use, wildlife on properties, reviewed by County Parks Committee, next steps, impact on City if purchased, funding available for maintenance, County being responsible for negotiations and final purchase, and answered Board questions regarding ownership of former roadway gap in property.

Recess was taken from 2:52 p.m. until 2:56 p.m.

Assistant City Manager Clinch continued to answer Board questions on Bellagio being a gated community, private roadways of adjacent neighborhood, access challenges, Board providing a statement of support, City Council review after County approval, potential uses, and current stage of the process.

City Manager Lavallee spoke on the Board authority and the Legislative Referral process.

Application for Girl and Butterflies Statue Along with Interpretive Elements at Centennial Park (Historical Resources Manager Harry Klinkhamer)

Historical Resources Manager Klinkhamer and Bob Vedder, applicant, presented location, proposed stones showings a butterfly's life cycle, site of former garden club, image of donated statue, Venice Area Beatification Inc (VABI) Butterfly Committee, site maintenance by VABI, map of proposed location, concept of painted butterflies on power pole, and answered Board questions regarding planned signage, butterfly design on power pole, size of plot of land, drawing of proposed site with design and plantings, butterfly decal, using native plants, and whether FPL approval is needed for decorating pole.

City Manager Lavallee spoke on Board's ability to review project, to make recommendations of approval or denial only, and adding stipulations.
