On the weekend of March 1, 2014 two events occurred in the downtown area: The Farmer's Market operated on Tampa Avenue on Saturday morning, and the Art Show organized by Venice Main Street took place on West Venice Avenue on Saturday and Sunday. Following is a review of the impact of those two events.

Background:

The Farmer's Market operates on Tampa Avenue on most Saturday's . The event begins to set up at 6:00 AM and closes for business at 1:00 PM. Following the closing of the event approximately one hour is required to break-down the market and clear the public roadway. From the time of set up to the reopening of the road barricades are in place to detour vehicle traffic from the section of Tampa Avenue occupied by the Farmer's Market. During this time, Centennial Park is accessible, and specific access lanes are established for emergency vehicle access. On a limited number of occasions the Farmer's Market has not been allowed to operate because of other large-scale events simultaneously occurring in the downtown business district. The Farmer's Market Manager reports that those closing are harmful to the individual vendors and cause inconvenience to patrons.

The Venice Main Street Art Show is a weekend event that operates on West Venice Avenue. The event begins set- up on Saturday, early in the morning, to ensure that private vehicle traffic does not impede the vendor set up area. The event occupies the roadway on Venice Avenue from the intersection of Business 41 to the intersection at Harbor Drive. The event lasts two days. During that time, the event venue on Venice Avenue is closed to general vehicle traffic.

Event Review:

Due to the influx of patrons to the Art Show in previous years the Farmer's Market has not been allowed to operate on the same weekend. However because of the popularity of both special events City staff worked with the principal organizers of both to develop a traffic and public safety plan to allow operation of both special events at the same time. The preparation and work plan consisted of the following:

- Working with the Police Department to assess the projected traffic influx and create a vehicle detour and parking plan
- Review and refinement o the event footprints to ensure that emergency travel lanes were accessible and that
 events contained their activities to their respective permitted locations
- Creation and placement of a parking sign scheme to direct patrons and others to designated parking
- Monitoring of parking signs to ensure that they remain in place and are effective in directing vehicle traffic
- Designation of on-site personnel from each event to be present during hours of operation to monitor activity and communicate with public safety and public works personnel
- Development of After-Action reports to evaluate the impact of the events

Venice Main Street maintained on-site personnel during event hours and conducted informal business reviews with local shops following the event. Kat Quast met with staff following the Art Show to obtain feedback on the effectiveness of the public safety plan. Specific issues of interest are ways to accommodate local businesses during special event weekends. A meeting is being scheduled in March to discuss general downtown business activities. Linda Wilson, Farmer's Market Manager prepared an event review report (attached) that summarizes the event strengths and suggestions for improvements. Both event leaders worked together to prepare for coordinated public services.

City staff also monitored the events. Public safety, impact on local businesses and residents, and citizen access to the special events and to other Venice sites, were primary issues of interest. Among the findings were the following:

- The intersection of Business 41 and Tampa Avenue was backed-up continuously, even after the closing of the Farmer's Market on Saturday. The cause of the congestion was the absence of a left-turn arrow in the traffic light sequence for vehicles traveling north on Business 41. Staff has been advised that the installation of a left-turn arrow has been reviewed and will be approved by FDOT. This one traffic tie-up caused vehicles to back up to the Venice Avenue Bridge, causing other traffic concerns including grid-lock at the Venice Avenue x Business 41 intersection
- Efficient traffic control at the intersection of Business 41 and Venice Avenue is critically important during special events. A police officer is needed at that location during event hours to regulate traffic flow
- The staff is inquiring from FDOT about the potential of issuing authority to local police for interim alteration of the traffic light sequence on Business 41 during special events.
- Vehicle detour and parking signage was helpful but could be further improved

The staff's general assessment is that with continued collaborative planning among the special events principal coordinators, additional planning and work with staff to effectively market the events, improved signage and traffic control at key intersections, and continued coordination with the business population in the affected areas, these two events can effectively operate simultaneously
