SUBJECT / TOPIC: New Special Event: Veterans Day in Venice

BACKGROUND INFORMATION: The New Events Review Team (NERT) has reviewed the submitted proposal for the 2025 Veterans Day in Venice event and recommends it for City Council review and approval. Included please find:

This event was successfully held in 2024 as a Park Reservation without vendors and featured musical performances by veterans. The event organizer, who is also a veteran and existing permitted event holder, remains committed to delivering an event that is by veterans, for veterans.

The 2025 proposal expands on the previous format by including mobile food vendors, along with retail, artisan, and veteran-owned business vendors. Veterans Day in Venice is intended as a community celebration dedicated to honoring those who have served and continue to serve. Through music, connection, and shared appreciation, the event aims to bring people together in tribute to veterans from all branches and backgrounds. This event will be a recurring annual celebration held on the Saturday following Veterans Day, or the second Saturday in November, ensuring it remains close to the date of its intended recognition while avoiding conflicts with other recurring heritage events. The 2025 date will be Saturday, Nov. 8.

The proposed site plan includes use of the Centennial Park lawn and gazebo, as well as the west portion of the adjacent parking lot to stage vendors, while maintaining the eastern section near the information kiosk for public parking.

City support will include the presence of Venice Police Department officers for security and traffic control, Solid Waste staff for trash and recycling mitigation, and use of the City's special events trailer for event setup. The event holder will be responsible for the placement of hardened barricades to secure the pedestrian-only areas of the park.

We will follow the City of Venice's emergency weather procedures and coordinate rescheduling or cancellation if necessary.

3. Event Support, Needs, and Amenities

Solid Waste:

- City recommendation for a smaller dumpster
- Will include cardboard bins and recycling cans based on vendor types
- Coordination will continue based on finalized vendor list

Venice Police / EMS:

- Per NERT stipulation, one VPD Officer will be present to assist with:
 - Traffic control
 - Mid-way parking lot closure
 - Pedestrian safety downtown
- At least two officers will be on site during alcohol service hours remaining on site at least 30 minutes after last call per Special Events policies and guide
- We will coordinate directly with VPD SEC will facilitate VPD coordination with event hodler

Tents / Structures:

- No tents larger than 10'x10'
- All vendor and info booths compliant with current city code

Utilities:

- No water hookup needed
- Quiet, self-contained generators may be used by vendors for power supply needs

Event Signage:

• All signage will be designed and placed in accordance with City code

✓ City Review & NERT Recommendations

This event has received a **positive recommendation from the City of Venice's New Event Review Team (NERT)** with the following key conditions, which **we have accepted and integrated**:

- Scheduling: Beginning in 2026, we agree to schedule the event on the second weekend of November (e.g., Nov. 14, 2026) to avoid overlap with the VMS Downtown Art/Craft Festival
- Safety & Traffic: One VPD officer will be on-site to assist with traffic, pedestrian safety, and parking lot closure
- Waste Services: We support the City's recommendation for cost-saving waste management, using smaller dumpsters, recycling bins, and cardboard containers
- Barricades/Site Map: Our provided site plan with hardened barricades has been reviewed and deemed acceptable




Next Steps & Confirmation
