RESOLUTION NO. 2023-44

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA, AMENDING RESOLUTION NO. 2021-31 TO ADOPT A REVISED USE OF LOGO POLICY; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City Council adopted Resolution No. 2021-31 to centralize adopted policies and delineate the parties responsible for oversight; and

WHEREAS, the Use of Logo Policy adopted therein requires clarification in order to properly effectuate it; and

WHEREAS, it has been determined that it is in the best interests of the City to adopt a revised Use of Logo Policy.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA, as follows:


SECTION 1. The whereas clauses above are ratified and confirmed as true and correct.

SECTION 2. The "Logos" Section of Resolution No. 2021-31 is hereby amended to adopt the Use of Logos Policy attached here to as Exhibit "A" in place of attachment VCC-I.

SECTION 3. Except as amended herein, Resolution No. 2021-31 shall remain in full force and effect.

SECTION 4. This Resolution shall take effect immediately upon approval and adoption as provided by law.

Use of Logos Policy

Approved October 10, 2023

- A. The following two logos have separate and distinct uses approved by the City Council and described herein.



This logo, depicting Venice City Hall, shall be used to specify policy-level government work of the City Council, such as on Council letterhead and emails, Council proclamations, Council Member business cards and clothing, and agendas for Council and for Boards which are created by or advisory to the City Council **such as on entrance signs to the City, the website, and awards or recognition. This logo should also appear on any Council related directives that may be jointly held with staff/operations. This logo should also be used for any council directed boards and activities.**



This logo, depicting the approved centennial logo, shall be used with the approval of the Mayor, council, or City Manager for purposes of celebrating our Centennial from November of 2025 until July 2027.




The main visual component of this logo, depicting a seagull in the sunset, shall be used for City operational activities and staff marketing, such as on entrance signs to the City, the website, internal departmental committees and workshop notices, City staff emails, letterhead, employee recognition, some City

- B. The following logos shall be modified only with the consent of the City Manager and final approval by the City Council.



This logo, depicting fire service, should be used on City of Venice Fire Department stationery, patches, uniform shirts and other items related to the Venice Fire Department.



This logo, depicting a Venice law enforcement badge, should be used for Venice Police Department stationery, patches, uniform shirts, and other items related to the Venice Police Department.



This logo, representing the Florida Commission, is the Law Enforcement Accreditation logo, which is also included in Venice Police Department Letterhead.



These two patches are used on sleeves of uniforms to distinguish between sworn police officers and civilian employees.

C. Any additional logos created or used by the City Of Venice not depicted in this policy shall be approved or modified only with the consent Of the City Manager and final approval by the City Council and shall be primarily comprised Of the seagull in the sunset logo.
