I would request that an item be placed on the 12-12 agenda. I would like the Planning Department to provide a list of all properties in the city that have not been assigned a city of Venice zoning classification. This, of course, was identified as a huge concern in the Sawgrass community because of city misfeasance or maladministration. I understand we have a similar circumstance with regard to the former Murphy Oaks property and that there are other sites never given a zoning designation in harmony with our comprehensive plan.

Action requested: I would like the council to direct the staff to identify appropriate zoning designations consistent with the Comprehensive Plan for all parcels not currently holding a city zoning classification.
