An update on the two traffic-related items you recently asked about:

- Crosswalks: Two or more of the crosswalks on West Venice Avenue were cleaned and restriped with reflective paint as an interim measure to installing more permanent lighting. The reflective paint contains sand or silica and provides enhanced visibility at night when illuminated by vehicle headlights. The more permanent solution is incorporated into the downtown street upgrade plan that is tied to the road bond issue
- The City staff is working with FDOT and the County to determine if the traffic signal currently in place at Harbor Drive v West Venice Avenue has the capacity to add another phase to the current lighting sequence. The staff had already determined that the left-turn phase would be beneficial. I am asking staff for a time projection to get an answer on the capacity of the current traffic light. The answer to that question will impact a determination as to whether adding the added phase is likely to happen. If the answer is that the current traffic light would have to be replaced or augmented, that will impact the issue in terms of possibility and time ( labor, materials, and work assignment- by other agencies)
