I attended [by zoom] the Planning Commission's August public hearing regarding this petition. I highly agree with concerns raised over building siting [rear of building facing sidewalk and Venice Avenue]. Drive-through feasibility [facing oncoming west-bound Venice Ave. traffic].
