**Proposed Ordinance Title:** ORD. NO 2025-25. An Ordinance Amending City of Venice Ordinance No. 2024-25, which adopted the Official Budget of the City of Venice, Florida for the Fiscal Year Beginning October 1, 2024, and Ending September 30, 2025; by increasing the total revenues and total expenditures by \$9,091,600; and Providing an Effective Date.
