Vice Chair Eydie Kargas called the meeting to order at 3:00 p.m.

Ms. Stelzer referenced Executive Order No. 20-69 issued by Governor DeSantis and Executive Order No. 2020-04 issued by the city regarding public meetings, commented on public participation in public meetings, and read instructions for audience participation in council chambers.

III. Approval of Minutes

A motion was made by Mr. Effron, seconded by Ms. Petway, that the Minutes of the January 27, 2020 meeting be approved as written. The motion carried unanimously by voice vote.

V. New Business

Gulf Coast Community Foundation (GCCF): Proposal for a Sea Turtle Sculpture at Venice Beach Park

Kelly Carlstein, Gulf Coast Community Foundation (GCCF), commented on the foundation's 25th anniversary, and spoke to bringing attention to marine debris affecting our waters, turtle sculpture to include material and location at Venice Beach Park, presented a short video clip of the sculpture and a picture of signage, and responded to board questions regarding placing recyclables in the sculpture.

Mr. Clinch spoke regarding interactive sculpture and staff placing clean recyclables in the turtle.

Discussion followed on engagement with the local schools, sculpture finish and material, project timeline, obtaining council's approval, sculpture location, child safety, and signage advising no climbing on sculpture.

A motion was made by Mr. Effron, seconded by Ms. Andrews, to accept GCCF's proposal for a sea turtle sculpture at Venice Beach Park and recommend approval to city council. The motion carried unanimously by voice vote.

Jon Thaxton, GCCF, thanked the board for their service and the city for engaging students on the board.

IV. Audience Participation

Michael Wendroff, 213 Portofino Drive, representing the Venetian Golf and River Club Community Association, spoke to the need of parks in northeast Venice, the city establishing a northeast Venice park stakeholder's work group, and requested the board's support.

Discussion followed regarding development and green space in northeast Venice, fast tracking process, including John Nolen's Plan in developments, and protecting green space for human health and environmental quality.

Mr. Clinch responded to board questions on available park land in northeast Venice, and spoke to meeting area needs, obtaining resident feedback, site selection, providing board with a copy of the memorandum prepared to council requesting approval of the stakeholder's work group, and park impact fees.

20-4715 Monty Andrews: Centennial Park Plaque Proposal

Monty Andrews, America in Bloom, spoke to his request to place a recognition plaque for Bob Vedder in Centennial Park.

Discussion followed regarding the city's policy on memorials and plaques, vetting process, Mr. Vedder's background, having a broad recognition of all citizens in the community, ability to remove plaque, and no cost to the city.

Benny Weaver, 1307 Pine Needle Road, spoke to Mr. Vedder's work and involvement in the community.

Discussion ensued regarding Mr. Vedder's work in the community and passion for the city.

A motion was made by Ms. Andrews, seconded by Ms. Roberts, to recommend to city council approval of the plaque donation honoring Bob Vedder to be placed in Centennial Park. The motion carried unanimously by voice vote.

20-4716 Earl Midlam and James Clinch, Director of Public Works & Asset Management: Approval of the "Old Betsy" Display Building Conceptual Plan (10 min.)

Mr. Hinshaw advised he will be leaving soon for another meeting.

Mr. Clinch and Earl Midlam, Former City Council Member and City Fireman, provided a presentation and spoke to Old Betsy's history, 2011 restoration, fire truck being featured in special events, current storage facility, concept plan, climate controlled display building, proposed location in East Blalock Park, and building rendering.

Mr. Hinshaw left the meeting at 4:17 p.m. and did not return.

Discussion followed regarding green space at the location, considering a mannequin with a uniform from the appropriate time period in the display area, vandalism, security measures, hurricane grade structure, capturing Old Betsy's history, project timeline and funding, and public display of concept plan.

A motion was made by Mr. Effron, seconded by Ms. Andrews, to recommend to city council approval of the Old Betsy display building conceptual plan. The motion carried unanimously by voice vote.

Mr. Wormley provided an update on the re-opening of the Venice

Community Center, and athletic leagues at Wellfield and Chuck Reiter Parks.

20-4718 Sarasota County PARC Update

Ms. Andrews reported on Sarasota County Parks Advisory and Recreation Council (PARC) meetings and requested board members provide ideas on land acquisition to recommend to the county.

20-4719 City of Venice Update

Mr. Clinch provided an update on Centennial Park's Gazebo, Higel Park's dock, Paw Park's deck and parking area, Maxine Barritt Park's pavilion, Venezia Park's playground structure and park impact fee project, city hall project, downtown aluminum pergola, charging stations at Centennial Park and the new public safety facility, upcoming projects to include walking path at Paw Park, resurfacing parking lot at Graser Park, bench replacements at Michael Biehl Park, and northeast Venice Park.

Discussion followed regarding Australian pine roots at Venezia Park and upcoming sunshine training on November 5, 2020 at 3:00 p.m.
