Mayor Feinsod called the meeting to order at 9:03 a.m.

#### CC 21-03PP

Consider and Act Upon Preliminary Plat Petition No. 21-03PP for Rustic Road South to Develop a Four Hundred Single-Family Residential Unit Subdivision Located South of Rustic Road Between I-75 and Knights Trail Road (Quasi-Judicial)

Mayor Feinsod announced this is a quasi-judicial hearing and opened the public hearing.

Ms. Fernandez questioned council members regarding ex-parte communications and conflicts of interest. There were none.

There were no written communications.

Mr. Lavallee announced Mr. Clark had been appointed Planning and Zoning Director.

Mr. Clark, being duly sworn, responded to council questions regarding the status of the road, access, fire marshal, Honore Avenue extension, complete street elements, sidewalks, county standards, width of road, emergency access, gate, Phase | and Phase | II, development standards, and accessory structures.

Jackson Boone, agent, being duly sworn, presented on the preliminary plat petition, including Rustic Road improvements through Sarasota County, sidewalks under I-75 bridge, approval of Florida Department of Transportation (FDOT), emergency access in phase I, and answered council questions regarding noise, gun range, and buffer with I-75.

Jordan Schrader, Clearview Land Design, being duly sworn, spoke about FDOT pond, extra buffer, drainage conditions, vegetation, landscaping, fencing, elevations, stormwater pond, and optional eight-foot wall.

Mr. Boone answered council questions regarding the gun range, written disclosures, visual indication, buffers, and neighborhood meetings.

Mr. Cautero commented on the noise from I-75 and gun range and buffers.

No one signed up to speak.

Mayor Feinsod closed the public hearing.

Ms. Fernandez answered a council question regarding the motion and noted council is approving the plat and no other modifications were needed.

## CC 21-05PP

Consider and Act Upon Preliminary Plat Petition No. 21-05PP for Rustic Road North to Develop a Two Hundred Ninety-Six Single-Family Residential Unit Subdivision Located Northwest at the Intersection of Ranch Road and East of I-75 (Quasi-Judicial)

Mayor Feinsod announced this is a quasi-judicial hearing and opened the public hearing.

Ms. Fernandez questioned council members regarding ex-parte communications and conflicts of interest. There were none.

There were no written communications.

Council declined a staff presentation.

Jackson Boone, agent, being duly sworn, requested the staff report be adopted as part of his presentation, the petition is consistent with the comprehensive plan and requested approval of the preliminary plat petition.

An Ordinance Amending the Official Zoning Atlas of the City of Venice, Florida, Pursuant to Zoning Map Amendment Petition No. 21-06RZ, Relating to Property in the City of Venice Located at the Eastern Terminus of Gene Green Road (44.34± Acres) Owned by the City of Venice, to Change the Zoning Designation from Planned Industrial Development (PID) to Government Use (GU); Providing for Repeal of all Ordinances in Conflict Herewith; Providing for Severability; and Providing for an Effective Date (Quasi-Judicial)

Mayor Feinsod announced this is a quasi-judicial hearing.

Ms. Stelzer read the ordinance by title only.

Mayor Feinsod opened the public hearing.

Ms. Fernandez questioned council members concerning ex-parte communications and conflicts of interest. There were none.

There were no written communications.

Council declined staff presentation.

No one signed up to speak.

Mayor Feinsod closed the public hearing.

#### VI. NEW BUSINESS

#### **ORDINANCES**

ORD. NO. 2021-41 An Ordinance of the City of Venice, Florida, Providing an Annual Update of the Five Year Capital Improvement Schedule for Fiscal Years 2022-2026 Including A Long Range Schedule of Capital Improvements for Years 2027-2031 Contained in the Appendix of the City of Venice 2017-2027 Comprehensive Plan; Providing for Repeal of All Ordinances in Conflict Herewith; Providing for Severability; and Providing for an Effective Date

Ms. Stelzer read the ordinance by title only.

Mr. Clark provided a staff presentation and answered council questions regarding table 7A, five-year plan, funding source, and the capital improvement program.

Discussion ensued on priorities, funding sources being unknown, projections, not getting into the details, and this being a framework.

Mr. Pachota called for a point of order to give staff the opportunity to present.

Mayor Feinsod spoke regarding county roads and stated this is not a funding schedule.

Mr. Clark noted this is not a funding document, but an opportunity to set priorities for projects and schedules, it is necessary for level of service and is consistent with the capital improvement program (CIP). He reported on the priorities and rankings, within city boundaries, but are county or state facilities or roads that have been identified as having issues and/or failures through traffic studies done by traffic professionals. Mr. Clark discussed volume to capacity (VC) ratios, Pinebrook Road from East Venice Avenue to Center Road, adaptive traffic signals, Edmondson Road and Auburn Road, letting the owners of these facilities know the city's priorities, Sarasota County Commission, Department of Economic Opportunity (DEO), Florida Department of Transportation (FDOT), Metropolitan Planning Organization (MPO), and that other agencies will be seeking funding.

Discussion took place regarding traffic on Pinebrook Road, signalization, and the west bound failure at the intersection.

Mr. Clark commented that the engineering and planning departments did a traffic presentation at the CIP workshop.

Discussion continued regarding the Sarasota Memorial Hospital (SMH) driveway, Laurel Road, emergency access, funding for the signal, and communication with FDOT.

Discussion ensued regarding priorities, circumstances, Pinebrook Road, and Venice Avenue.

Mr. Clark discussed volume to capacity ratios and consistency.

Dr. Neunder left the dais at 9:44 a.m. and returned at 9:46 a.m.

Mr. Clark responded to council request for documentation on studies and failures

Recess was taken from 10:35 a.m. until 10:45 a.m.

Dr. Neunder left the meeting at 10:43 a.m. and did not return.

Mr. Clark displayed Dr. Fiedler's proposed rankings.

Mr. Clark responded to an inquiry that these studies indicate the priorities and traffic studies are done with new developments and the same failures have continued to be identified.

Mr. Lavallee stated this is a moving target, top priorities have not moved, and this is an opportunity for council input and recommendation.

Discussion continued regarding contributions, data, and rankings.

Mr. Cautero called the question.

A motion was made by Council Member Kelly, seconded by Council Member Moore to approve Ordinance No. 2021-41 on first reading and schedule it for final reading.

A motion was made by Dr. Fiedler, seconded by Council Member Kelly to amend the motion to include the priority chart, as presented. The motion failed by the following vote:

Dr. Fiedler withdrew Item Nos. 21-5285 and 21-5286.

<u>21-5286</u> Direct Staff to Provide an Update on the Northeast Park, Including Status, Vision, Location and Timeline (Fiedler)

Mr. Lavallee stated that staff is in discussion and negotiations regarding property acquisitions and when a proposal is complete it will come to council.

21-5287 Discussion on Meeting Procedures (Pachota)

Mr. Pachota spoke regarding how meetings are conducted and Resolution No. 2021-43 regarding meeting attendance, points of order, and technology due to pandemic. He would like to keep order on the dais and if the mayor or vice mayor is not in person, recommended having council elect an in-person chair to preside over the meeting.

Discussion followed on meeting efficiency, points of order not being recognized, technology issues, and successfulness of the hybrid format.

Mr. Pachota noted there will be new council member(s) coming in, meetings have not been fluid and recommended amending the resolution to function efficiently for constituents and the city.

Discussion took place regarding the technology, issues, and solutions.
