- > Lori, please copy all council members with this request. Thank you.

- > After 4 appearances before City Council during the past 10 years no street lights have been installed on Harbor Drive from the side of City Hall to the end of the apartment district that ends on Armada. Last year Mayor Holics response to this neighborhood request was "It may be sooner than you think."
- > During this last administration with Mayor Martin it had been approved; then because of the budget cuts that request was pulled. HOWEVER The City then paid to install lights every 25 feet outside the walled development on E. Laurel Road. That "request" did not go through the normal channels. Money talks.
- > There is no street light on the corner of, or on the side of City Hall. The first street light is on the corner of Menendez by the firehouse. The second street light is on the far side of Armada. The Belmont and Lanzilotte apartments and the Windsor House Condos all in the apartment district have NO street light the length of the block. The median is full of shade trees adding to the darkness. You can barely see people approaching you on your side of the street, let alone on the far side of the street. Even the coyote remains invisible .
