Senior Planner Nicole Tremblay presented the project description, the applicant's request, Venetian Urban Design, Overlay District, MUC Island DU/AS, Land Use Maps, Comprehensive Plan Consistency, Conclusion, Strikethrough Underline Proposal, and answered Council questions regarding the unit breakdowns, and unit counts.

Jeffery Boone, Agent for Applicant, presented the petition, the need for

redevelopment, current surrounding properties, and reviewed the mixed use corridor, proposal of percentages in Comprehensive Plan, the comprehensive plan amendment, and the conversion factor.

Jim Collins, Agent for Applicant, provided an explanation of the conversion factor.

Attorney Boone continued addressing traffic analysis, entitlements, increased density, showed list of addresses, units, John Nolen, future site and development plan, requested approval, and answered Council questions regarding the development units, building height, and conversion factor.

Carrie Luber, 405 Rio Terra, spoke on improvement of the property, against increased capacity, and traffic concerns.

Mayor Pachota closed the public hearing.

#### **B.** PRESENTATION WITH ACTION

#### 25-0074 Police Chief Andy Leisenring and Captain Louis White: Speed Enforcement in School Zones

Police Chief Andy Leisenring and Captain Louis White provided a presentation regarding automated speed enforcement in school zones, current statistics, facts of the program, notice to public, being officer verified, potential penalty, fund distribution, City's responsibilities, vendor's responsibilities, benefits of program, support from other organizations, study conducted of violations in Venice school zones, and answered Council questions regarding officer verification, fine assignment, hours of operation, statistics of driver types, and reason for making request now.

Discussion took place regarding being in favor of the program, concerns for current number of violations, using as a deterrent compared to an income source, license plate readers in the City, crosswalks in Epiphany School zone, providing clear signage, plan after it is no longer needed, concerns for privacy and public opinion, vendor selection, and hours of operations.

There was no public comment.

A motion was made by Vice Mayor Boldt, seconded by Mr. Engelke, to direct staff to pursue the installing of speed enforcement cameras in school zones. The motion carried by the following electronic vote:

<u>25-0075</u> Finance Director Linda Senne: Quarterly Financial Update (10 min.)

Finance Director Senne presented the quarterly financial update, including revenue projection, tax revenue received, local gas tax, fire and police premiums, communication tax, utilities services taxes, franchise fees for natural gas, licenses and permits collections, intergovernmental revenue, charges for services, EMS transport fees, interest on investments, miscellaneous, General Fund expenses, departments over budget, ending fund balance, projections, estimates, and answered Council questions on the lease of South Jetty adjustments, and percentages being on track from previous years.

## D. COUNCIL ACTION/DISCUSSION

25-0076Historical Resources Manager Harry Klinkhamer: Consider the Citizen<br/>Advisory Board's Recommendation for City Council to Approve<br/>Placement of a John Nolen Statue at the Southeast Corner of<br/>Centennial Park

Historical Resources Manager Harry Klinkhamer and Robert Vedder presented a proposal for a John Nolen statue, recommended location in Centennial park, coordination with Public Works, Citizen's Advisory Board recommendation, sample of statue, including copy of John Nolen Venice Plan, and images of John Nolen.

A motion was made by Mr. Smith, seconded by Vice Mayor Boldt, to accept the Citizen Advisory Board's recommendation and approve placement of a John Nolen Statue at the Southeast Corner of Centennial Park.

Support for the project was expressed.

The motion carried by the following electronic vote:

Encouragement was expressed to the other applicant to apply in the future and the desire to reappoint these candidates due to their short initial term, due to a new board requiring staggered terms.

<u>25-0078</u> Discuss Bayshore Road Project (Mayor Pachota)

Mayor Pachota introduced the topic.

Ms. Farrell stated she requested the item be placed on the agenda due to concerns about coordination with the sidewalk and force main projects, and the needs of the residents.

Jim Leftwich, 329 Bayshore Drive, stated safety was not an issue and there have not been accidents.

Norbert Bellendir, 309 Bayshore Drive, spoke against a sidewalk on Bayshore Drive.

Sam Humphreys, 344 Bayshore Drive, spoke on safety and support for a sidewalk, increased cost due to project delays, and the value of human life.

Danny Piper, 336 Bayshore Drive, spoke in support of a sidewalk, spoke on individuals being injured while avoiding traffic, reasons for choosing the west side for a sidewalk, speed, and congestion.

Joan Piper, 336 Bayshore Drive, spoke in support of a sidewalk on Bayshore Drive, safety, people sustaining injuries, and accessibility.

Cynthia Eliopoulos, 212 Bayshore Circle, spoke on safety concerns, support for sidewalks on Bayshore Drive, infrastructure not changing with population, street narrowing, no shoulders, open swales, and the history of a proposed sidewalk.

City Attorney Fernandez answered a Council question regarding safety concerns, expert recommendations, and risk of litigation.

A motion was made by Mayor Pachota, seconded by Vice Mayor Boldt, to direct staff to hold community workshops and engage a consultant to evaluate best options for the entire stretch of Bayshore Drive through Laguna and determine a project that suits the majority of residents, all while pausing the current design that's in place. Discussion took place regarding residents concerns, involvement, tax payers throughout the City, division of the neighborhood, safety, the project not being stopped, encouraging residents, staff and consultant to look at all types of options, road being too narrow, property values, insurance rates, speed limit, and compromise.

Assistant City Manager James Clinch and Assistant City Engineer Jon Kramer answered Council questions regarding the water main project being a couple of years out, sidewalk being done this summer, the water main for that section of block will be handled before the sidewalk, project timeframe, cost, and criteria for choosing the west side.

Discussion continued regarding concerns about the west side intrusion, need for deadline, and stakes placed in yards.

Assistant City Engineer Kramer answered a question regarding the stake placement.

Discussion continued regarding sticking to the facts, staff studies, liability issue, protecting human life, and time being of the essence.

Assistant City Manager Clinch answered a Council question on when staff can bring back a proposal and a conceptual design, scheduling a workshop, and pausing design work while pursuing all options.

Discussion continued regarding the revenue stream, phasing of the project, and staff bringing an update to Council on March 11th.

The motion carried by the following electronic vote:

- 25-0079 Request Approval of Funds for Venice Theatre Matching Grant (Mayor Pachota)

Mayor Pachota introduced the topic, and proposed a \$125,000 matching grant toward hurricane recovery.

Mr. Wilson, 601 Armada Road South, spoke against using taxpayer money to fund a private organization, concerns about ethical ties to the theatre, and encouraged private donations.

A motion was made by Mayor Pachota, seconded by Mr. Engelke, to approve a \$125,000 matching grant to the Venice Theatre for capital improvements related to hurricane recovery.

Discussion took place regarding economic impact to downtown Venice, decrease in ticket sales, not-for-profit status, history in community, Venice Performing Art Center (VPAC), library, Venice Area Beautification Inc. (VABI), Venice MainStreet, stimulating other grants and funding, marketing, safety funds toward hurricane recovery, support for the theatre, role of municipal government, staffing, police staffing, firefighter pay, other non-profits, and affordable housing being in the strategic plan.

City Attorney Fernandez, answered a Council question regarding conflicts of interest, and addressed voting conflicts that apply to those that are financial in nature.

Recess was taken from 3:43 p.m. to 3:50 p.m.

City Attorney Fernandez reiterated Council Members must vote unless there is a financial conflict and noted Vice Mayor Boldt does not have a statutory conflict of interest.
