ORDINANCE NO. 2025-21

AN ORDINANCE AMENDING CITY OF VENICE ORDINANCE NO. 2024-25, WHICH ADOPTED THE OFFICIAL BUDGET OF THE CITY OF VENICE, FLORIDA FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2024 AND ENDING SEPTEMBER 30, 2025; BY INCREASING THE TOTAL REVENUE BY \$417,890 \$319,000 AND TOTAL EXPENDITURES BY \$417,890 \$319,000; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Venice, pursuant to Section 200.065, Florida Statutes, adopted its Operating Budget, Revenues and Expenditures, and Capital Improvement Program for Fiscal Year 2025 by approving Ordinance No. 2024-25 on September 24, 2024, said budget being \$180,113,955; and

WHEREAS, the City of Venice increased said Operating Budget by the amounts of certain commitments for purchases (i.e., encumbrances) and projects, totaling \$34,346,468 and \$27,889,513 respectively, up to an "Adjusted Original Budget" amount of \$242,349,936 for Fiscal Year 2025; and

WHEREAS, the City of Venice amended its Fiscal Year 2025 budget by approving Ordinance No. 2024-28 on December 10, 2024 for an increase of \$8,350,500, said budget as amended being \$250,700,436; and

WHEREAS, the City of Venice amended its Fiscal Year 2025 budget by approving Ordinance No. 2025-06 on January 28, 2025 for an increase of \$398,928, said budget as amended being \$251,099,364; and

WHEREAS, the City of Venice amended its Fiscal Year 2025 budget by approving Ordinance No. 2025-10 on February 25, 2025 for an increase of \$500,000, said budget as amended being \$251,599,364; and

WHEREAS, the City of Venice amended its Fiscal Year 2025 budget by approving Ordinance No. 2025-18 on May 13, 2025 for an increase of \$1,494,951, said budget as amended being \$253,094,315; and

WHEREAS, the City of Venice desires to further amend its Fiscal Year 2025 budget by increasing the total revenue and total expenditures by $\frac{417,890}{5319,000}$ as detailed in Exhibit "A", attached hereto, said budget as amended being $\frac{253,512,205}{5253,413,315}$; and

WHEREAS, of the revenue needed to cover increased expenditures, \$23,753 comes from outside police services, \$161,000 comes from General Fund reserves, and \$158,000 comes from the Fleet Replacement Fund; and \$75,137 comes from the Police Impact Fees Fund reserves; and

WHEREAS, this amendment is authorized by Section 166.241(8), Florida Statutes.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA:

<u>SECTION 1.</u> Ordinance No. 2024-25, which adopted the City of Venice Operating Budget, Revenues and Expenditures, and Capital Improvement Program for Fiscal Year 2025, as previously amended, is hereby amended as detailed in Attachment "A," which is attached hereto and incorporated herein by reference.

<u>SECTION 2.</u> This Ordinance shall become effective immediately upon its approval and adoption, as provided by law.
