V. Public Hearing

PLAR24-001 34 780 Firenze Avenue East - Seeking a Recommendation for City Council on Placing the Municipal Mobile Home Park Clubhouse in the Local Register

of Historical Resources

Applicant: City of Venice

Vice Chair Trammell announced this is a quasi-judicial hearing, read the memorandum regarding advertisement, and written communications, and opened the public hearing.

Assistant City Attorney Lewis questioned Board members concerning ex-parte communications and conflicts of interest. There were none.

Historical Resources Manager Klinkhamer, being duly sworn, presented an aerial map, building being constructed in 1942, nomination categories, structure history, historical aerial photo, site photo, photo of original features, and answered Board questions on ownership, whether there are plans to improve the structure, current management of building, maintaining historic interior details, whether registration would provide opportunity for grants, whether there are sufficient funds to maintain structure, concerns for architectural changes done to the structure, applicant details, and the airport's authority on property.

There was no one signed up to speak for audience participation.

Vice Chair Trammell closed the public hearing.

A motion was made by Mr. Steketee, seconded by Ms. Dearybury, that based on review of the application materials, the staff report and testimony provided during the public hearing, the Historic and Architectural Preservation Board finds this petition consistent with the Comprehensive Plan, in compliance with the Land Development Code and with the affirmative Findings of Fact in the record, recommends to City Council approval of Nomination to the Local Register for 780 Firenze Avenue East with the stipulation that historic interior features be retained. The motion carried by the following roll call vote:
