Planner Smith presented petition background, general information, location map, site photos, surrounding properties, future land use, current and proposed zoning, county coordination, Joint Planning Agreement (JPA) and Interlocal Service Bounty Agreement (ILSBA), Policy 8.2, Comprehensive Plan consistency, Land Development Code compliance, provision of services, findings of fact, and planing report and action.

Attorneys Annie Boone and Jeffrey Boone, Agents, presented site map, project size, existing zoning, JPA, and annexation's consistency with JPA, Comprehensive plan, voluntary annexation, statutory requirements and city code.

C. Mariah Wozniak, 1107 Twin Laurel Boulevard, spoke on wildlife, fairness in development, and flooding.

Attorney Jeffrey Boone, Agent, spoke regarding flooding not being a part of annexation, current properties for sale, and the annexation does not allow development.
