Human Resources Director Alan Bullock and Ray Carter, The Gehring Group: Renewal of Property and Liability Insurance for Fiscal Year 2025 (10 min.)

Human Resources Director Bullock and Ray Carter provided a presentation of the renewal of property and liability insurance for FY 2025 to include vehicle insurance and liability, general liability, law enforcement liability, excess workman's compensation coverage, flood insurance, public officials coverage, and answered a Council question regarding pollution liability and explained it was related to water recovery and distributions, fuel spills, and clean up operations. They also commented on drone coverage, lowering or increasing deductibles, and positive trends in Workman's Compensation.
