**Proposed Ordinance Title:** ORD. NO 2026-18. An Ordinance Amending City of Venice Ordinance No. 2025-32, as Previously Amended, Which Adopted the Official Budget of the City of Venice, Florida for the Fiscal Year Beginning October 1, 2025 and Ending September 30, 2026; by Increasing the Total Revenue by \$4,916,229 and Total Expenditures by \$4,916,229; and Providing an Effective Date

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes.
