Please enter my name on the list of future candidates for service on the City of Venice Planning Commission.

From 1969 to 1971, I served on the Milford, CT Planning and Zoning Board.

From 1984 to 1992, I served on the West Windsor, NJ Planning Board. During my service, the community grew to double its size with all the corresponding planning issues. Most serious at the time was the State's implementation via the courts, of the "Mount Laurel" low and moderate income housing decision. This decision required each community to plan to set aside land for higher density projects, regardless of local zoning regulations. After years of planning and negotiations with the courts and developers, several large projects were approved satisfying our obligation.


Since retiring to Venice in 1993, I have served on the Waterford Master Owners Association as Director for two years, and President for four years. As mentioned on my application, during this time, I was responsible for the successful transfer of part of Capri Isles Blvd. from the City to our Association. It was groundbreaking for the City which had never given up ownership of a roadway, and for the Association as well, incorporating it into our system of private roads.

Throughout my time here in Venice, I have maintained an avid interest in Planning Commission and City Council activities.
