At the request of the Utilities Department, we evaluated the following vehicles:

Unit # 266: The 1998 Ford E-150 van is in rough condition and the vehicle is showing signs of wear. The vehicle is going to need costly repairs in the near future. The value of the vehicle along with needed and projected repairs aids us and recommending this vehicle be disposed of at this time.

Unit # 267: The 2002 GMC Sonoma pickup truck has several issues and is in need of costly repairs. Do to these issues we recommend this vehicle be disposed of at this time.

Unit # 220: The 2000 Ford Utility Truck has several concerns not only with the vehicle but the crane system as well. The costly repairs exceed the value of repairing this vehicle so we recommend it be replaced at this time.

At the request of the Public Works Department, we evaluated the following Units:

Unit # 103: The 1982 Ford Dump Truck does not run and has been sitting for approximately three years. The body is deteriorating and the vehicle does not run. Due to the high mileage and year of this vehicle we are recommending that it be disposed of at this time.

Unit # 412: The 2000 Pontiac Grand Prix has high mileage and runs poorly at this time. The vehicle has not been on line for approximately two years and is not in very good condition. The vehicle shows signs of extreme wear and we are recommending it be disposed of at this time.

Unit # 212: The 1980 Ford 445 Tractor has several issues with the steering and hydraulic systems. Due to the age and poor condition of this tractor and the excess cost of needed repairs we are recommending that this tractor be disposed of at this time.

Unit # 450: The 1994 Toro Mower has several issues with the body and mower attachments. Due to the age, excessive hours, condition and repair costs to return this Unit to operating capacity it is recommended that we dispose of this Unit at this time.
