

RESOLUTION NO. 2023-33

A RESOLUTION PROVIDING FOR THE CITY OF VENICE GENERAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 7, 2023, TO ELECT TWO COUNCILMEMBERS FOR THREE-YEAR TERMS; DESIGNATING POLLING PLACES FOR THE ELECTION; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, there is a Sarasota County administered election to be held on Tuesday, November 7, 2023; and

WHEREAS, early voting provides citizens greater access to elections and facilitates increased voter participation; and

WHEREAS, advertising the elections are required by law and provides citizens with greater knowledge of the elections.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA:

SECTION 1. The above Whereas clauses are ratified and confirmed as true and correct.

SECTION 2. Early voting will take place at the Sarasota County Supervisor of Elections office, Robert L. Anderson Administration Center, 4000 S. Tamiami Trail, Room 114, beginning on Monday, October 30, 2023, and ending on Saturday, November 4, 2023, between the hours of 8:30 a.m. and 4:30 p.m. daily.

SECTION 3. Tuesday, November 7, 2023, between the hours of 7:00 a.m. and 7:00 p.m. is designated as the day on which the annual general municipal election will be held in the City of Venice for the purpose of electing two council members for a three-year term respectively.
