Over 28 years in Banking/Financing. Advanced from bank teller to President and CEO of finance and mortgage banking company. Established Resource Financing, Inc., a finance company, in 1984 and was essential in its acquisition by the First National Bank of Lisbon in 1995. Currently, a member of the Bank's Board of Directors. Over 17 years in Law Enforcement in Dutchess and Ulster County. Over 18 years in residential and commercial real estate. Offer strong teadership, analytical, organizational, interpersonal, and communication skills.

PRESIDENT/CEO

Founded and personally funded Resource Financing, Inc in January 1984. The corporation quickly developed into a licensed mortgage banking firm governed by the New York State Banking Department. Directed the capitalization by filing a Stock Prospectus which included offering interest-bearing accounts to prospective investors which were secured in part by the mortgage portfolio. These interest-bearing notes delivered rates of return 75-150 basis points higher than any bank or credit union in the Hudson Valley with no penalty for early withdrawal. This allowed Resource Financing to raise an additional \$2,000,000 over the stockholders' investments and supplemented the established line of credit. The business was successful but short of capital. After negotiations and intensive diligence Resource Financing, Inc. was acquired by The First National Bank of Lisbon in October of 1995. Remained to manage Resource Financing as a division of the Bank as Executive Vice-President until October of 1997. Currently remaining as a member of the Bank's Board of Directors.

While holding this position, the Board of Directors appointed me Director of Security for the bank. Designed a security training program for all tellers.
