Clerk Michaels read the ordinance by title only.

A motion was made by Vice Mayor Boldt, seconded by Mrs. Frank that Ordinance No. 2024-08 be approved on first reading and scheduled for final reading.

Jim Perry, 577 Misty Pine Drive, spoke on elections, requested an explanation on why this item was not sent to the Citizen Advisory Board (CAB) and Charter Review Committee, asking where the proposal initiated, the election cycle, and recommended Council abandon this plan.

Joan Roscoe, 882 Wood Sorrel Lane, spoke on the election cycle, other Florida municipalities whose elections do not coincide with the county/national elections, and encouraged a thorough review.

Steve Heffler, 487 Padova Way, spoke on elections, respect for City Council, voter perception, community input into discussion before putting it on the ballot.

George Davis, 121 Castile Street, spoke against having elections only on even years, and the benefits of odd year elections.

Debbie Gericke, 146 Bella Vista Terrace, spoke on extension of election terms, straight ticket voters, non-partisanship, stated a four-year cycle will skew the Council, recommended keeping the Council well-rounded, public optics, and a lack of property appraisal for recent lease agreement amendment.

Ruth Cordner, 246 Montelluna Drive, spoke against changing the election cycle, benefits of odd year elections, other municipalities in the United States who hold off cycle elections, public perception and trust, and financial priorities.

Dean Calamaris, 13 Gulf Maonor Drive, spoke on elections, history, issues with being on even year only elections, partisanship which was not previously an issue.

Maureen Graybil, 5 Gulf Manor Drive, spoke against changing the election cycle, and in favor of off year elections.

Joe Nisi, 5030 Seagrass Drive, spoke on elections, and the benefits of turnover in public officials.

Nancy DeForge, 332 Laurel Hollow Drive, spoke on the history of election terms, local elections, and the importance of informed voters.

Discussion took place regarding the reasons behind the proposal, history not being a reason to leave things the same, concern about voter burnout, agreement with issues citizens have brought up, option to postpone the issue, the topic being considered twice in the past 15 years, sending it to the Charter review committee, wording of the ballot question, importance of good leadership, evaluating information based on the facts, voters' capabilities, the length of ballots should not be an issue, the money not being insignificant, the voters being the decision makers, other municipalities, election cycles, and clarifying the language.

City Attorney Fernandez responded to a Council question, stating the City cannot produce a fact sheet to send out to voters/citizens, information can only be posted for voters to access of their own accord, do not need to change the charter to reference the additional year, as it is only transitional.

A motion was made by Mr. Smith, seconded by Ms. Farrell, to postpone this issue indefinitely so the charter review committee can be convened to make recommendations on it and any wording for the ballot. The motion failed by the following electronic vote:

# C. PRESENTATION

### 24-0196 Planning and Zoning Director Roger Clark: Sawgrass Update

Planning and Zoning Director Clark provided an update on the potential Sawgrass Rezoning which was pulled in February, stating staff has reviewed the complex and long history, the City zoning district is unique to Sawgrass, not taking away any property rights, there are no indications to change current uses, there is no requirement to change zoning, City has previously enforced Sarasota County zoning on the property, and mutual agreement from both primary owners to leave zoning as is.

Council thanked staff for the thorough analysis, the in-depth summary, and appreciation for parties coming to an agreement.

# D. PRESENTATION WITH ACTION

24-0198 Finance Director Linda Senne: Budget 3% Cap

Finance Director Senne presented a request for approval to exceed the 3% budget cap for FY2025, and answered a Council question regarding the assessed property values, noting the actual numbers will be received from the Property Appraiser soon, and stated the fund balance/reserves will be carried forward, but are not allocated for current year expenses (FY25).

A motion was made by Vice Mayor Boldt, seconded by Mr. Howard, to approve the request to exceed the 3% Budget Cap for Fiscal Year 2025 Budget. The motion carried by the following electronic vote:

Assistant City Manager Clinch and Historic Resources Manager Klinkhamer provided a presentation on the proposed Centennial Celebration Plan to serve as a guiding document to include stakeholder organizations, background, themes and objectives, timeline and city events, budget and projected costs, community outreach, engagement and participation, next steps.

Assistant City Manager Clinch and Historic Resources Manager Klinkhamer answered Council questions regarding the event approval process, long-term usage of signs and history plaques at parks, especially John Nolen Park, picture books funding. Council thanked staff, and noted there were opportunities to work with friends of the involved non-profits.

A motion was made by Mr. Smith, seconded by Ms. Farrell, to schedule a workshop to collectively set goals for the Charter Officers for the next year as envisioned in the evaluation process Council Members have been asked to complete.

Mr. Smith asked if the Director of Human Resources would be able assist with SMART (specific, measurable, attainable, relevant, time-based/trackable) goals in a workshop.

Director of Human Resources Bullock commented on employee evaluations, the Council body overseeing the work of the Charter

Officers, a new form being developed two years ago, done on an individual basis, recommended having something on the record, no direct link to pay, and noted evaluations of the Charter Officers are not required.

Discussion continued requiring Council members to fill out forms, not needing a workshop, confidentiality, whether the budget is for the position or individual, difficulty in evaluating operations, issues with making a public record, consulting an employment attorney, group goals being an option, one-on-one conversations to address issues on an ongoing basis, guidance from the Director of Human Resources, only Council being able to evaluate, suggested tool, and not a requirement.

Discussion took place regarding a second reading not taking place after staff learned of a potential issue and staff pulled the ordinance, and whether it was appropriate since staff had originated the application, or whether it was no longer a staff request.

City Attorney Fernandez stated the matter was handled appropriately. However, if Council wanted the process to work differently they could give that directive.

Discussion continued whether any changes needed to take place to the process, concerns about spreading inaccurate information, transparency, and Council has ability to act as intended.
