Field Conditions Need To Be Addressed

Invest In Our Youth – Capital Improvements Needed

- We met with Sarasota County officials (Mr. Rauh and others) on 4/6/22.
- Mr. Rauh informed us fields, especially field #2, is infested with nematodes (a.k.a. roundworms). These nematodes are extremely harmful to durability of sod, and has wreaked havoc on these fields.
- Mr. Rauh informed us and pointed out in his email to city officials on 7/19/21, the only effective course of action is a complete renovation of the fields – removal and replacement of first 4-6 inches of soil.
 - Mr. Rauh provided proposals to address the field conditions on 8/5/21, and the "band aid" approach was chosen.
 - As you can see from the pictures, the "band aid" approach just isn't sustainable, and our youth deserve better.

Subject: RE: Wellfield Park - Soccer Fields Question

Good morning James,

Thank you for reaching out. Ed and I were just discussing these specific fields this past Friday. As I'm sure you're aware these fields receive a high volume of use. In particular, field #2 has had nematode issues (info on nematodes attached) in the past that we've treated for (although they periodically return). Our discussion on Friday included the likelihood that these fields (all three soccer fields) would need to be fully renovated sometime in the near future. This would include the removal and replacement of the first 4-6 inches of soil and subsequently new sod/turf applied. It would also be beneficial to conduct an irrigation audit while renovating to ensure proper system use. This scale of work would undoubtedly exceed the amount of capital expenditure that the county is authorized to apply on an annual basis.



Invest In Our Youth – Capital Improvements Needed

- Request City of Venice to invest in the complete field replacement of all three soccer fields (at minimum fields 1 & 2).
- Work with Venice Soccer Club (VAYSA) on most cost effective plan.
