V. NEW BUSINESS

PRESENTATIONS

Don Ross, Director of Operations, John Burkette, Associate, Kessler Consulting Inc.: Solid Waste Study (15 min.)

Mr. Ross reviewed his company's background along with study results, noting the city solid waste collection was a very well run operation with a high level of service to city residents. Mr. Ross reviewed operational costs, pointed out that the existing manual collection process was maxed out, and recommended a fully automated collection system.

Discussion ensued regarding educating city residents on an automated system, maneuvering collection carts, recycling, justifying changes associated with automated systems to city staff and city residents, prior solid waste studies, there not being significant cost savings, charging per bag of yard waste, considering employee safety, long range planning, and continuing the existing level of customer service.

Mr. Veneziano reviewed existing programs to assist disabled residents and commented on collecting the necessary data prior to concerting to a "pay as you throw" system.

Council member discussion continued regarding making recycling profitable to providers.
