## **CALL TO ORDER**

Mayor Pachota called the meeting to order at 9:00 a.m.

#### ROLL CALL

Gary Scott, 156 Pesaro Drive, expressed concerns on Unified Control, open space, land use, rezoning Planned Unit Developments (PUDs), the Land Development Regulations (LDRs), predictability, and protection for homeowners.

Debbie Gericke, 146 Bella Vista Terrace, expressed concerns about the definition of Unified Control, and recommended City Council seek an outside attorney for guidance. She also made suggestions about the ranking process for the Citizen Advisory Board.

Jeffery A. Boone, PO Box 1596, spoke on Unified Control and in favor of having a defined process to amend PUDs.

Jan Vertifuelle, 321 Pedro Street, spoke against the ranking process for the Citizens Advisory Board, and recommended using the board in a meaningful way.

Suzanne Jerry, 118 Savona Way, spoke on Unified Control and PUD amendments.

Steve Carr,149 Avens Drive, recognized City Stormwater Engineer Steve Berens for his work on Curry Creek, and Assistant Director of Utilities Patience Anastasio for communication regarding neighborhood issues.

Kathy Walters, 273 Bocelli Drive, spoke on Unified Control, her homeowners association (HOA) board, and environmental concerns.

#### V. PRESENTATION

24-0055 Finance Director Linda Senne: Quarterly Financial Update (10 min.)

Finance Director Senne provided the quarterly financial update, general fund, revenues, and expenses.

## VI. PRESENTATION WITH ACTION

24-0056 Planning and Zoning Director Roger Clark: Unified Control Discussion

Planning and Zoning Director Clark provided a presentation on Unified Control, previous code language, amending a PUD, rezoning the entire PUD, and whether or not Unified Control has to be re-established.

Discussion took place regarding percentage of homeowners in agreement, LDR requirements, minimum per Comprehensive Plan and LDRs, developers rights, history of PUDs in Venice, four options, appropriate percentage, property rights, designated areas, and HOA quorums.

City Attorney Fernandez noted we cannot make the LDRs more restrictive prior to October 2026, and Council needing to consider this would apply to all amendments that come before them, staff direction, property rights, amendments guidelines, need for direction, details can be adjusted, possibility of a workshop, concerns about developer control, considering a consultant, and issues that are outside the City purview.

Discussion took place regarding whether or not to include a specific option, the need for a workshop and possibility of a consultant.

Recess was taken from 11:15 a.m. to 11:25 a.m.

Discussion continued regarding not limiting to one option, whether to look for consultant, balance between homeowner and property rights, and the importance of being applicable in our state.

A motion was made by Mr. Smith, seconded by Ms. Farrell, to direct staff to come back with a modified version of option 2, to have a workshop, and have professionals to advise us on the best way to accomplish this. The motion carried by the following electronic vote:

Discussion took place regarding concerns about the flooding and stormwater issues, Flamingo Ditch is, but would like an update and information, causing back up and flooding of streets.

Clerk Michaels introduced the topic, received corrected rankings, others to resubmit, or submit, all rankings in now and compiled, the top 15 presented as requested.
