## **RESOLUTION NO. 2022-34**

A RESOLUTION RELATING TO MEETING ATTENDANCE BY CITY COUNCIL; ADOPTING AN AMENDED POLICY FOR ATTENDANCE AND FOR PARTICIPATION BY REMOTE ELECTRONIC MEANS; SUPERSEDING RESOLUTION NO. 2022-25; AND PROVIDING AN EFFECTIVE DATE

**WHEREAS,** Section 3.07(b) of the City Charter was amended by a vote of the electorate on November 8, 2022, to provide that a councilmember shall forfeit office if the councilmember fails to attend in-person three regular meetings in a calendar year without being excused by the city council; and

**WHEREAS,** Section 2-75(f) of the City Code of Ordinances provides the reasons for which a councilmember's complete absence from a meeting will be excused; and

WHEREAS, the Florida Attorney General has rendered opinions that recognize the legality of remote appearance by a member who for good cause cannot appear in person to participate remotely by electronic means, as though physically present, with all participation rights and voting privileges provided that there is a quorum physically present, that the member can hear and be heard by those present, and that there is a local policy allowing such appearance.

**WHEREAS,** Resolution No. 2022-25 established revised criteria for virtual attendance by a city councilmember; and

**WHEREAS,** the City Council desires to amend the policy for virtual attendance to be consistent with Section 3.07(b), as amended.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA:

**SECTION 1.** As used in City Charter Section 3.07(b)(4), "attend" shall mean being present at the meeting for the entire duration of the meeting.

**SECTION 2.** Any councilmember who cannot attend any portion of a regular meeting of the city council shall so notify the Clerk's Office as soon as practicable, preferably before the start of the meeting, along with the reason for such absence if excusal is desired. A city councilmember shall be excused from attendance by the City Council if the reason for absence is one identified in Section 2-75(f) of the City Code.

**SECTION 3.** A councilmember may attend a regular or special meeting remotely by electronic means with the same participation rights and voting privileges as though physically present, and be deemed excused from in-person attendance, provided all the following criteria are met:

1. There is a quorum physically present at the meeting location.

- 2. The councilmember has provided notification to the city clerk of the inability to attend in person along with the reason for such request as soon as practicable before the start of the meeting. In-person attendance shall be deemed excused if for one of the following reasons: xxxx. For any other reason, if a councilmember desires to be excused from in-person attendance such request must be voted on by the City Council at the start of the subject meeting.
- 3. The councilmember can be visible and audible to and from the members present at the meeting and the audience. For quasi-judicial matters, any councilmember appearing remotely must be and remain visible for the entire agenda item.

**SECTION 4.** This resolution shall supersede and replace Resolution No. 2022-25.

**SECTION 5.** This resolution shall take effect immediately upon adoption.
