<b>BACKGROUND INFORMATION</b> : This is to fill the expiring resident term of Richard Cautero. The vacancy was posted once and only Mr. Leatherbury applied. The requirements are two members shall be legal residents of the city, appointed by city council, and two members shall be members of the system, elected by a majority of firefighters who are members of the system. The fifth trustee shall be chosen by a majority of the previous four trustees, submitted to city council, to appoint, as a ministerial duty, as its fifth trustee.
