Proposed Ordinance Title: Ordinance No. 2026-20: An Ordinance of the City of Venice, Florida, Amending the Code of Ordinances, Chapter 88, Building Regulations, Amending Section 3.4, Unsafe Structures, in its Entirety; Providing for Repeal of All Ordinances in Conflict Herewith; Providing for Severability; and Providing an Effective Date

In accordance with the provisions of controlling law, even notwithstanding the fact that an exemption noted above may apply, the City of Venice hereby publishes the following information:

1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals, and welfare): The proposed ordinance repeals and replaces the City of Venice's existing unsafe buildings provisions to establish updated procedures for the identification, notice, appeal, repair, rehabilitation, condemnation, and demolition of unsafe buildings and structures. The ordinance provides a comprehensive administrative process for addressing structures that pose a threat to public health, safety, and welfare due to unsafe, unsanitary, dilapidated, abandoned, or otherwise hazardous conditions. The ordinance also establishes procedures for appeals to a Special Magistrate, authorizes compliance agreements, provides emergency enforcement authority when immediate hazards exist, and allows the City to recover costs associated with the abatement of unsafe structures. The public purpose of the ordinance is to protect life and property, promote public safety, prevent structural failures, reduce hazards to occupants and the public, and preserve the health, safety, and welfare of the community.

2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the City of Venice, if any: The proposed ordinance is expected to have minimal direct economic impact on private, for-profit businesses within the City of Venice. The ordinance primarily updates and clarifies the City's administrative procedures for addressing unsafe buildings and structures, including notice requirements, appeals, compliance agreements, condemnation procedures, and emergency actions.
