Under the proposal, that could occur only if the speaker was the attorney for or had a legal power of attorney signed by the other person. As a practical matter that would rarely occur.

At their April 23 meeting, City Council will consider two proposals that Venice Thrives has concerns about:

Reducing public comments at their meetings: The city attorney and city clerk have submitted a memo recommending that City Council limit when the public can speak at Council meetings by:

- restricting public comment to the one-hour audience participation section at the beginning of each meeting and eliminating the option to speak when specific agenda items are being discussed. (Quasi-judicial public hearings are the exception.)
- eliminating the ability of Council members to respond to public comments during audience participation. Although such responses are uncommon, explicitly forbidding them needlessly limits Council's interaction with citizens.
- restricting the ability of a member of the public to read another resident's comments into the record as is currently allowed when someone is unable to attend in person. Currently a resident has 5 minutes for each comment; the change would mean they get 5 minutes combined.

Venice Thrives believes that public participation at City Council meetings is an essential part of effective and informed local government and that the current process works well. Listening to their constituents should be a high priority for our elected officials. If you agree, please email citycouncil@venicefl.gov before Tuesday and urge them not to change public participation rules for their meetings.

Changing the city's election cycles. Since 1927, the Venice City Charter has mandated that the mayor and City Council serve three-year terms, with staggered elections so that two members of Council are elected each year. The mayor has proposed changes to that election cycle, in the name of saving money, by eliminating elections that don't coincide with County Commission election years.

This would mean that members would serve four-year terms instead of three. And to

accomplish this quickly, **City Council will consider proposals that would add an extra year onto the current terms of up to five members of Council.** To do this, they will have to change the City Charter and hold a citizens referendum this November.

Venice Thrives believes that if changes are made to the election process, current City Council terms should not be extended. The voters elected City Council to three-year terms and any extension of that period contradicts the will of the voters. If you agree, write to citycouncil@venicefl.gov.

Was present in city hall during a meeting when Fiedler & Moore were talking about their desire to restrict audience speaker resident participation related to quasi judicial hearings and other meetings that occur last year. This discussion occurred because of the Neal vs Resident citizen organized Coalitions hearing that had transpired.

A few councilors needed to have the process explained related to how one resident is able to represent others . The lawyer for Venice shared the opinion that the builder is often not present but represented by a lawyer and that lawyer last yeat claimed more time to speak as well sharing that he represented other businesses permitting him to speak at greater length . She said the citizens also have this capability if the proper forms are filled out and verified as valid which operate somewhat like a proxy vote . Signatures on these forms are required for the representative speaker which then permits that speaker additional time . This is how democracy works . Both of these councilors shared the opinion that residents should not be permitted to have someone ride other than a lawyer represent them . That statement puts only the wealthy developer in the drivers seat and relegate the citizen as a walker who is not permitted to pass GO . The developer is given a Pass to do whatever he pleases .

Venice becomes a different city between early May through late October early November . The tax paying citizens number tens of thousands in droves that venture elsewhere for extended periods of time . Alot of times developers and other important considerations come into play related to important decisions made by the City Council . Developers know this and applications are often designed to be heard for approvals during these times believing and knowing that push back from residents will not exist in numbers . Emails can be sent but residents have learned these emails unless they number in the difficult to count numbers are not often considered as an automatic prompted texted response occurs .

You can have your staff scrutinize more carefully these forms and even call the folks supposedly being represented and even state that skirting the rules can result in being restricted from future speaker time. You can set up stricter protocols. We have sat in chambers a lot and seen one lawyer present and speak every single time you address any Venice development issue.

If you do this you also need to restrict access of the local town lawyer family in the city chamber and offices domain given the perception is that this family is provided a lot of latitude related to questionably ethical access to city staff and officials.

Visits and conversations to city hall offices by lawyers and citizens should be logged and visible and be placed on record.

The citizen speaker time is already limited in nature and regulated with proper forms in play.

We have video clips of various city councilors sharing their unbiased opinions related to wanting to restrict citizen resident speaker time . This won't bode well for the next city council election ejection outcome .

Changing the length of the terms and extending that time does not honor citizen tax payer representation . If a councilor is involved with elicit support of a lucrative individual or party this becomes clearly evident in the term already being served . Terms are established to establish a true democratic system .
